SUBJECT	15.C. Licensing Report

Licensing Unit Staff Update

On January 12, 2021, the Board promoted Marlenne Gonzalez from the receptionist position to fill the Veterinary Assistant Controlled Substance Permit (VACSP) licensing technician position vacated by enforcement analyst Melissa Caudillo. On March 2, 2021, the Board hired Dustin Garcia to fill the vacant veterinarian licensing technician position, and on March 15, 2021, the Board hired Rachel Adversalo to fill the Registered Veterinary Technician (RVT) licensing technician position vacated by enforcement analyst Jennifer Tarrant.

Renewal Requirements (Strategic Plan Objective 2.4)

The Board continues to receive inquiries regarding the fingerprint and continuing education (CE) requirements for licensure renewal. Inquiries generally vary between how to complete the fingerprint requirement and how to obtain the necessary CE.

The Board continues to send monthly informational email blasts to all stakeholders. The information includes important information regarding Board actions and programmatic and waiver updates. Stakeholders who contact the Board also are encouraged to sign up for the Board’s email blasts, and licensees are encouraged to update their email contact information with the Board.

California State Board Examination (CSBE) (Strategic Plan Objectives 2.3)

The Board approved a legislative proposal eliminating the CSBE as a requirement for licensure. The Board is requesting the California State Legislature include the proposal in the Board’s Sunset bill, Assembly Bill (AB) 1535 (Committee on Business and Professions, 2021). Board staff will monitor the Sunset bill throughout this session, and work with the Department of Consumers Affairs, Office of Information Services to update BreEZe.

Once the proposal is enacted, Board staff will run a report to identify all applicants, whose only remaining requirement was passing the CSBE, and issue licenses accordingly. Board staff also will provide outreach through ListServ, the Board’s website, and social media platforms. In addition, the Board will provide outreach to the American Association of Veterinary State Boards (AAVSB) and American Veterinary Medical Association (AVMA) to notify them of the eliminated requirement.

Licensing Unit Performance Measures

Applications

Through April 1, 2021, the Board has seen an increase from the prior quarter in the number of applications received, primarily attributed to VACSP and veterinary premises applications. The Licensing Unit received 1% more veterinarian applications, 3% fewer RVT applications, 40% more veterinary premises applications, and 53% more VACSP applications compared to last quarter. The Board received two university license applications, down from the eight received last quarter.

Additionally, the number of licenses issued as compared to last quarter has decreased overall. The licenses issued for veterinarians decreased by 17%, RVT registrations decreased 44%, and premises registrations decreased 24%. Additionally, university licenses issued decreased from eight to one. However, there was a 3% increase in VACSPs issued.

Board staff are making progress working on pending applications, with a majority of the pending applications decreasing from the last report. The pending veterinarian applications have increased due to staffing shortages and work done to improve BreEZe systems.

Processing Times and Pending Applications (Strategic Plan Objective 2.1)

Strategic Plan Objective 2.1 intends to “[d]ecrease licensure processing times by issuing a license to any candidate who completes the licensure requirements within 4 weeks to increase consumer access to veterinary care and to increase candidate access to licensure.” As demonstrated in the attached statistics, the average cycle time to process veterinarian license applications is 17 days, which exceeds the 28-day goal.

Increased BreEZe Usage (Strategic Plan Object 2.3)

As demonstrated in the attached Monthly Application Statistics report, paper applications for most license types have dramatically decreased. Over the last year, all applicants and licensees have been encouraged to use BreEZe when applying for and renewing licenses. All veterinarian, university license, RVT, and temporary license paper applications have been removed from the Board’s website. Premises registration and VACSP paper applications will be removed shortly. This transition to electronic application submission and processing not only streamlines the process for applicants, licensees, and licensing staff, but it significantly reduces physical mail received and processed through cashiering and front office staff.

The number of active veterinarian licenses and premises registrations decreased between March 2019 and May 2020. There were multiple contributing factors that could have led to this, including implementation of the Board’s fingerprint requirement for renewals, the fee increase,

and the COVID-19 pandemic. Since May 2020, the Board has seen an increase in the number of veterinarian licenses and premises registrations. Additionally, during this same time period, the Board has continued to see growth in RVT registration.
