## **International Council for Veterinary Assessment (ICVA)**

The ICVA is the examination developer and vendor for veterinary assessments, including the North American Veterinary Licensing Examination (NAVLE), and functions similar to the Department of Consumer Affairs (DCA), Office of Professional Examination Services (OPES). They produce a quarterly newsletter that provides updates to stakeholders, the most recent of which can be found [here](#). The newsletter has updates from their Chief Executive Officer, Heather Case, DVM, MPH, DACVPM, CAE, information about the ICVA Chair, NAVLE updates, award winners, program updates, and a recap from the June 2021 ICVA Board meeting.

## **Registered Veterinary Technician (RVT) Statistics**

Board staff continue to compile RVT candidate pass rates on the VTNE from data provided by the American Association of Veterinary State Boards (AAVSB). With this information, the Board is able to accurately enforce the RVT school pass rates as

required under California Code of Regulations (CCR), title 16, sections [2065.7](#) Inspections, and [2065.8](#) Probation.

### **RVT School Probation**

The Board may place a school or degree program on probation for a period of time not to exceed two years if “for a period of two years the approved school’s or degree program’s yearly average pass rate for first time candidates who have taken the registration examination falls below 10 percentage points of the state average pass rate for first time candidates who have taken the registered veterinary technician examination during the same time period.” (CCR, tit. 16, § 2065.8, subs. (a)(2).) The process for placing an approved program on probation is outlined in CCR, title 16, section 2065.8.2.

Prior to taking any action to place an RVT school or degree program on probation or withdraw the Board’s approval, the Board must provide the school or degree program notice of the pending action and an opportunity to be heard. To satisfy the regulatory requirement, the Board would need to select a date during a scheduled board meeting for which the Board’s approval of the school or degree program would be agendized for discussion, send notice to the school or degree program of the pending Board action, and advise the school or degree program of the Board meeting date.

Below are the pass rates for RVT school or degree programs whose students took the registration examination for the first time in Fiscal Year (FY) 2018/19, FY 2019/20, and FY 2020/21. Schools and degree programs that are below 10% of the state average pass rate for first time candidates appear in bold, red text.

Currently, the school that falls into that category is San Joaquin Valley College (SJVC). During the April 2021 Board meeting, the Board heard from SJVC, which submitted a report and explained measures they are taking to improve the program. Following review of the measures taken by SJVC to improve the RVT pass rates, the Board voted to not place the program on probation. The Board will continue to monitor the pass rates.

### **RVT School Inspection**

The Board is required to conduct inspections of approved schools every four years, pursuant to CCR, title 16, section 2065.7, subsection (a). Additionally, the Board may conduct inspections of these programs if, “for a period of two years the approved school’s or degree program’s yearly average pass rate on the registration examination falls below 10 percentage points of the state average pass rate for first time candidates for the registered veterinary technician examination.” (CCR, tit. 16, § 2065.7, subs. (b).)

Below are the yearly pass rates for schools and degree programs that include first time test takers and candidates retaking the VTNE. Schools and degree programs whose candidates tested below 10% of the state average pass rate for first time candidates

appear in bold and red text. Schools and degree programs whose yearly pass rates fell below 10% of the state average for two years are subject to Board inspection pursuant to CCR, title 16, section 2065.7, subsection (b)(2).

The Board reached out to these schools previously regarding the low pass rates for their schools and discussed the responses at its July 2021 meeting. The schools provided information and speculation as to why the pass rates were low and indicated measures were being taken to improve their programs and, consequently, their pass rates.

## **Renewal Requirements** (Strategic Plan Objective 2.4)

The Board continues to receive inquiries regarding continuing education (CE) requirements for licensure renewal and how to obtain a waiver from those requirements due to COVID-19 impacts. In response to these inquiries, Board staff explain the license renewal waivers issued by the DCA Director. The most recent DCA Director waiver, issued on September 28, 2021, applies to individuals whose active licenses expire between October 1, 2021, and October 31, 2021.

Staff have begun working with the DCA, Office of Information Systems (OIS) to have BreZE automatically notify licensees via email of missing fingerprints on renewals that have been paid. This automation will allow staff to be more efficient by removing the manual email notifications.

**California State Board Examination (CSBE)** (Strategic Plan Objectives 2.3)

Board staff are currently informing stakeholders that the CSBE and California Licensing Curriculum are still required for licensure in California.

Board staff attended the 3-day California Licensing Curriculum held by the California Veterinary Medical Association on September 13, 2021 and explained the Board's role in veterinary medicine.

**Increased BreZE Usage** (Strategic Plan Object 2.3)

As demonstrated in the attached Monthly Application Statistics report, the licensing population has primarily converted to online applications. All applicants and licensees are encouraged to use BreZE when applying for and renewing licenses. Paper applications have been removed from the Board's website. Additionally, staff are working with OIS to make improvements to BreZE and automate applications to reduce delays in licensure and license/permit updates.

**Licensing Unit Performance Measures**

**Applications**

Through September 30, 2021, the Board has seen a decrease from the prior quarter in the number of applications received. The Licensing Unit received 40% fewer veterinarian applications, 14% more RVT applications, 16% fewer veterinary premises applications, and 12% fewer VACSP applications compared to last quarter. The Board received 17 university license applications, the same as last quarter. This decrease in applications, specifically for veterinarians, can be attributed to the standard fluctuation from school graduations - specifically students having to wait until they are within eight months of graduation.

Consequently, the number of licenses issued as compared to last quarter has decreased overall. The licenses issued for veterinarians decreased by 40%, RVT registrations decreased 44%, premises registrations decreased 23%, and VACSP registrations decreased by 63%. Additionally, there were 12 university licenses issued, an increase of one from last quarter. Again, this decrease in licenses issued corresponds to licensure requirements.

Compared to the prior Fiscal Year quarter one totals, the Board has seen a decrease of 4% in the total number of applications received and 30% decrease in the number of licenses and permits issued. Board staff are making progress working on pending applications, with a majority of the pending applications decreasing from the last report. The pending VACSP applications have increased slightly.

**Processing Times and Pending Applications** (Strategic Plan Objective 2.1)

Strategic Plan Objective 2.1 intends to "[d]ecrease licensure processing times by issuing a license to any candidate who completes the licensure requirements within 4

weeks to increase consumer access to veterinary care and to increase candidate access to licensure.” As demonstrated in the attached statistics, the average cycle time to process veterinarian license applications is nine days, which exceeds the 28-day goal.
