Examination Updates

International Council for Veterinary Assessment (ICVA)

On May 16, 2022 the ICVA opened its assessment grant program which will award up to three grant award opportunities for \$10,000. The purpose of the assessment grant is to validate current, discover new, implement and support best practices in assessment in veterinary medical education. This includes assessment of students, instructors, and programs. Faculty from accredited veterinary schools are encouraged to apply for educational grants focusing on student assessment and feedback. The deadline to submit a grant proposal for 2022 ends September 30, 2022. More information can be found on the [ICVA Assessment Grant Program website](#). Deadline for the letter of intent was June 24, 2022, and invitations for the full proposal will be July 29, 2022.

On June 7, 2022 the ICVA announced Janine Hawley as their new Chief Innovation Officer. Ms. Hawley had worked on the North American Veterinary Licensing Examination (NAVLE) for over 20 years, and now she will work with the Chief Executive Officer and Chief Assessment Officer to implement board-approved strategies, policies, and operational procedures for ICVA's assessment portfolio.

Additionally, the [NAVLE Candidate Bulletin](#) has been released for the November-December 2022 and April 2023 testing windows. The bulletin is sent to all NAVLE candidates at the time of their application.

Examination Statistics

The North American Veterinary Licensing Examination (NAVLE) and the Veterinary Technician National Examination (VTNE) returned to their routine examination scheduling and grading. The NAVLE was offered from April 11-23, 2022. The VTNE was offered March 15 - April 15, 2022. Examination results are posted below.

Licensing Updates

BreEZe Updates (Strategic Plan Object 2.3)

Continued improvements were made to the Board's interface with the American Association of Veterinary State Boards (AAVSB) which now has a daily operation to check for scores and attach them to candidate files. This works for candidates who are actively testing for the NAVLE and have selected California as their jurisdiction to receive results. Candidates who took the NAVLE with another jurisdiction must still require a separate transmittal of their NAVLE scores to the Board.

The VACSP application process was updated to an automatic process, which will approve applications that do not have discipline attached to them from fingerprints. This process improvement will greatly reduce the processing times for those applicants as long as we have received the required fee and fingerprint clearance.

Additional improvements were made to applications regarding the criminal metrics tracking, requiring email addresses for veterinarian licensees, and outbound interface with the AAVSB to transmit enforcement and licensee status electronically.

Workforce Survey Information from HCAI for Licensees

The Department of Health Care Access and Information (HCAI), formerly known as the Office of Statewide Health Planning and Development (OSHPD), is partnering with the Department of Consumer Affairs (DCA) and the Veterinary Medical Board (Board) to collect important health workforce data. HCAI is the leader in collecting data and disseminating information about California's healthcare infrastructure. HCAI promotes an equitably distributed health workforce and publishes valuable information about healthcare outcomes.

With the passage of [Assembly Bill 133 \(Chapter 143, Statutes of 2021\)](#), HCAI is launching the [California Health Workforce Research Data Center \(Center\)](#). The Center will serve as the state's central repository for health workforce data, and will collect, analyze, and distribute information on educational and employment trends for healthcare occupations in the state. An annual report will be produced discussing:

- Supply and demand of the health workforce
- Geographical distribution of the health workforce
- Diversity of the health workforce, by specialty (including, but not limited to, data on race, ethnicity, and languages spoken)
- Current and forecasted demand for healthcare workers, by specialty
- Educational capacity to produce trained, certified, and licensed healthcare workers, by specialty and by geographical distribution

HCAI, in partnership with the Board and DCA, has developed a workforce survey for licensees to complete during their electronic licensure renewal process. HCAI and the Board are asking for your help with this important data collection effort, by completing this survey at time of licensure renewal. This data will help shape the future of health workforce policy in California. The workforce survey became available on July 1, 2022. HCAI plans to present data and findings from the Center at future Board meetings, social media posts, and other outlets.

Upcoming BreEZe Improvements

Board staff continue to work with OIS to plan and prioritize improvements in BreEZe. Upcoming scheduled improvements to BreEZe include primarily DCA global changes.

The Board specific BreEZe changes include internal updates to clarify enforcement codes for staff. This will remove redundant codes and add additional codes to enforcement activities to identify areas of violation more clearly. This improvement will assist current and new staff when selecting violation codes for individual cases.

Performance Measures

Applications

Board applications increased from the prior quarter, with 21% more veterinary premises applications and 16% more VACSP applications; however, the Board received 9% fewer veterinarian applications and 13% fewer RVT applications compared to last quarter. The Board received 15 university license applications, down from 18 last quarter. The Board received fewer applications this quarter, primarily due to many applicants waiting until AB 1535 was implemented and there were more applications received in the first quarter than typically received. Similarly, RVTs increased their applications in the first quarter, likely coinciding with the reduction in fees for applications. Compared to the same quarter last year, the Board received 3% more applications and issued 19% more licenses and permits.

Compared to the prior fiscal year, the Board overall received 3% more applications for all applicants except veterinarians. This was due to the Board combining its examination and license applications into one and eliminating its temporary veterinary licenses.

Additionally, while the number of applications may have decreased, the number of veterinarian licensees has been increasing.

Licenses

Overall, the Board issued more licenses compared to last quarter. The Board issued 204% more veterinarian licenses, RVT registrations increased by 2%, premises registrations increased 92%, and VACSP registrations increased by 9%. Additionally, there were 12 university licenses issued, an increase from the 3 issued last quarter. Again, this overall increase in licenses issued corresponds to licensure requirements and examination results – specifically the graduation of veterinarian candidates and VTNE results for RVT candidates.

Compared to the prior fiscal year, the Board issued 8% more licenses. There was an increase in licensure and registration for each type, except RVT, which saw a decrease of 9%. It should be noted that, although there was a decrease in RVT registrations issued, the number of applications received increased.
