Staff Update

On September 23rd, the Board's licensing technician, Andrea Amaya-Torres, accepted a promotional opportunity at the Board in the Inspections Unit. Ms. Amaya-Torres served the Board's licensing unit since 2018. The licensing unit appreciates her hard work and dedication and she will be a great asset to the Inspections unit.

Due to promotional opportunities, the licensing unit now has two vacancies. The positions were posted and reviewed and because of a limited application pool, the positions will be reposted. The vacancies are affecting the Board's application processing time. The Board is working the Department's Consumer Information Center (CIC) to borrow staff through a Memorandum of Understanding (MOU) and help alleviate the backlog.

To give staff more opportunity for upward mobility, they are encouraged to and taking advantage of SOILD training courses. SOLID training offers courses to be prepared for entry level classifications to analytical classifications.

Denied Application Research

This year's Sunset Review Report added two new licensing questions related to denied applications:

21. How many licenses or registrations has the board denied over the past four years based on criminal history that is determined to be substantially related to the qualifications, functions, or duties of the profession, pursuant to BPC § 480? Please provide a breakdown of each instance of denial and the acts the board determined were substantially related.

21a. What process does the board use to check prior criminal history information, prior disciplinary actions, or other unlawful acts of the applicant? Has the board denied any licenses over the last four years based on the applicant's failure to disclose information on the application, including failure to self-disclose criminal history? If so, how many times and for what types of crimes (please be specific)?


The Board did not previously track this information. In order to respond to the legislature, licensing staff created reports to identify all applications with a criminal history. Using this information, staff is manually pulling each application to determine if it was denied, when it was


denied, and the specific convictions. Staff still has roughly 800 conviction applications to review. A preliminary analysis of the results thus far indicates a much higher denial rate in prior fiscal years. In addition, it is unclear in many instances why the convictions were determined to be substantially related.

In light of the information this project revealed, staff will be contacting all prior applicants to inform them of their right to reapply and educate them on the AB 2138 provisions taking effect in July 2020.

Updated Renewal Process

Since the launch of the new online renewal process in May 2019, 70% of Veterinarian renewals and 85% of RVT renewals have been completed online through BreEZe. This is a significant increase from the 49% of Veterinarians and 56% of RVTs renewing online prior to the new process.





Applications

The licensing unit received 13% more veterinarian applications, 5% more RVT applications, and 6% less VACSP applications compared to last fiscal year.
