Examination Development Workshops

The Department of Consumers Affairs' (DCA) Office of Professional Examination Services (OPES) completed the Veterinarian Occupational Analysis (OA) and has reviewed North American Veterinary Licensing Examination (NAVLE) information. The OPES linkage study workshop was completed remotely between May 28 and June 11, 2020, and compared content of the NAVLE with the results of the California OA. The findings of the review can be found under Agenda Item 6.B. The outcome of the Board discussion will dictate the continued use of examination development workshops.

American Association of Veterinary State Boards (AAVSB) Coordination

Strategic Plan Objective 2.5 is to "[c]oordinate with [AAVSB] to enhance the evaluation of licensees' eligibility for licensure.

As discussed in more detail during Agenda Item 9.C., Board staff has collaborated with AAVSB on the current requirement in California Code of Regulations, title 16, section 2010.1 that all veterinarian license candidates apply with AAVSB to determine eligibility to sit for the NAVLE. Board staff, AAVSB, and the International Council for Veterinary Assessment (ICVA) all recommend repealing this regulation in order to streamline the examination process for all veterinarian license candidates. (Strategic Plan Objective 2.5)

Registered Veterinary Technician Statistics

Board staff and the DCA Office of Information Systems are continuing to work with the AAVSB to receive examination results through an automated process. We anticipate this being available early next year. (Strategic Plan Objective 2.1 and 2.5)
