The Board currently has 19 rulemaking packages that are pending in the regulatory process. Nine of those packages have been submitted to DCA and are in various stages of the initial or final phase of the rulemaking process, as identified in the attached document. The remaining ten packages are pending preparation by Board staff for submission.

Changes in the status of rulemaking packages since October 2020 are provided below:

Criminal Conviction Substantial Relationship and Rehabilitation Criteria (AB 2138 (Chiu, Ch. 995, Stats. 2018)) – California Code of Regulations (CCR), Title 16, Sections: <u>2040</u>, <u>2041</u>

Enacted and Effective on November 19, 2020

On November 16, 2020, DOF approved the Std. 399 Form (Economic and Fiscal Impact Statement). On November 17, 2020, Board staff submitted the Std. 399 Form to OAL. On November 19, 2020, the final rulemaking package was <u>approved</u> by OAL and <u>filed</u> with the Secretary of State; the regulatory changes became effective on the same date.

RVT Emergency Animal Care – CCR, Title 16, Section: 2069

Final Rulemaking Package Approved by DCA Director and Business, Consumer Services, and Housing Agency (Agency); Submitted to OAL for Final Approval

On November 24, 2020, the final rulemaking package was submitted to DCA for final review and approval. On December 5, 2020, the package was approved by the DCA Director, and on December 18, 2020, it was approved by Agency. On December 23, 2020, the package was submitted to OAL for final approval.

RVT Job Tasks – CCR, Title 16, Section: 2036

Final Rulemaking Package Approved by DCA Director and Agency; Submitted to OAL for Final Approval

On November 25, 2020, the final rulemaking package was submitted to DCA for final review and approval. On December 9, 2020, the package was approved by the DCA Director, and on December 22, 2020, it was approved by Agency. On December 24, 2020, the package was submitted to OAL for final approval.

Veterinarian-Client-Patient Relationships (VCPRs) – CCR, Title 16, Sections: 2032.15, 2032.25

Final Rulemaking Package Approved by DCA Director and Agency; Submitted to OAL for Final Approval

On November 24, 2020, the final rulemaking package was submitted to DCA for final review and approval. On December 12, 2020, the package was approved by the DCA Director, and on December 28, 2020, it was approved by Agency. On December 30, 2020, the package was submitted to OAL for final approval.

Fee Schedule (Certificate of Compliance) – CCR, Title 16, Sections: 2070, 2071

45-Day Public Comment Period Closed; Public Hearing Held; Board to Consider Responses to Public Comments

The 45-day public comment period closed on November 9, 2020, and a public hearing was held on November 10, 2020. At the January 28, 2021 meeting, the Board will consider responses to the public comments received. If no action is required, Board staff will proceed with preparing the Final Statement of Reasons (FSR) and final rulemaking package. As a result of the related Re-Adoption of Emergency Filing (discussed below), the Certificate of Compliance is due to OAL no later than June 25, 2021.

Fee Schedule (Re-Adoption of Emergency Filing) – CCR, Title 16, Sections: <u>2070</u>, <u>2071</u>

Notice of Intent to Re-Adopt Emergency Regulations Issued; Request for Re-Adoption of Emergency Regulations Filed and Approved by OAL; In Effect Until June 26, 2021

Due to the November 24, 2020 Certificate of Compliance deadline, OAL recommended that the Board file a re-adoption of the emergency regulations, which would extend the effective date of the Board's emergency regulations. On November 4, 2020, the Board issued a Notice of Intent to Re-Adopt Emergency Regulations. On November 12, 2020, the Board filed the request for Re-Adoption of Emergency Regulations with OAL; the 5-calendar-day public comment period closed on November 17, 2020. The Re-Adoption of Emergency Regulations was approved by

OAL on November 18, 2020, and became effective on November 25, 2020, for 90 days, plus an additional 120 days per Governor Gavin Newsom's COVID-19 related Executive Orders, <u>N-40-20</u> and <u>N-66-20</u>.

Animal Physical Rehabilitation (APR) – CCR, Title 16, Section: 2038.5

Responses to Written and Oral Comments and Proposed Modified Text Approved by Board; Proposed Modified Text Noticed for 15 Days; Board to Consider Letter Received During 15-Day Public Comment Period

On October 22, 2020, the Board approved: 1) responses to written and oral comments received during the 45-day public comment period and during the public hearing for inclusion in the Board's FSR; and 2) proposed Modified Text to address wildlife rehabilitation and APR performed on large animals. On November 19, 2020, the Board <u>noticed</u> the proposed <u>Modified Text</u> for 15 days, and the public comment period closed on December 4, 2020. One letter with recommendations was received, and the Board will consider that letter on January 28, 2021.

Drug Compounding – CCR, Title 16, Sections: 2090-2095

Responses to Written Comment and Proposed Modified Text Approved by Board; Proposed Modified Text Noticed for 15 Days; Board to Consider Letter Received During 15-Day Public Comment Period

On October 22, 2020, the Board approved: 1) responses to written comment received for inclusion in the Board's FSR; and 2) proposed Modified Text to address concerns raised in the written comment and to better clarify the proposal. On November 19, 2020, the Board <u>noticed</u> the proposed <u>Modified Text</u> for 15 days, and the public comment period closed on December 4, 2020. One letter with recommendations was received, and the Board will consider that letter on January 28, 2021.

Duties of a Supervising Veterinarian – CCR, Title 16, Section: 2035

Multidisciplinary Advisory Committee (MDC) Recommended Withdrawal of Rulemaking; Board to Consider Recommendation

Prior to the October 2020 MDC and Board meetings, Board staff, legal counsel, and the Board's Deputy Attorney General liaison reviewed the rulemaking and determined that it may not be necessary for consumer protection. On <u>October 21,</u> 2020, the MDC recommended withdrawal of the rulemaking. The Board will consider the MDC's recommendation on January 28, 2021.

Disciplinary Guidelines – CCR, Title 16, Section: 2006

Board to Consider Minor Modifications

On January 28, 2021, the Board will consider minor modifications to the Disciplinary Guidelines.

Eligibility Evaluation – National Veterinarian Examination – CCR, Title 16, Section: <u>2010.1</u>

Approved by Board

The regulatory proposal was approved by the Board at the October 22, 2020 meeting. The rulemaking package for this proposal is pending preparation by Board staff.
