Examination Updates

International Council for Veterinary Assessment (ICVA)

The ICVA is the examination developer and vendor for veterinary assessments, including the North American Veterinary Licensing Examination (NAVLE), and functions similar to the Department of Consumer Affairs (DCA), Office of Professional Examination Services (OPES). They announced an expanded testing window for the NAVLE, which will run from March 14 through April 30, 2022. Applications for the NAVLE will be accepted through February 1, 2022.

ICVA's latest In-Focus Newsletter can be found <u>here</u>. The newsletter discusses the "NAVLE Deep Dive and ICVA Report to Licensing Boards," as well as other examination-related topics.

In addition, the ICVA published its <u>NAVLE Technical Report</u>. This report documents the development, administration, and psychometric analysis of the 2020-2021 NAVLE.

Assembly Bill (AB) 1535 Implementation Impact Meeting

On December 16, 2021, the Board's Executive Officer met with the Chief Executive Officer of ICVA and the American Association of Veterinary State Boards' (AAVSB) Senior Director of Program Services to discuss the impact the Board's Sunset Bill (AB 1535) has on examination eligibility review. AB 1535 essentially removed the Board from examination eligibility review, since all requirements were moved to the license/registration application. This means all applicants will only apply to the Board once (rather than one time for the examination and one time for the license) when they meet all the licensing requirements.

While AB 1535 became effective January 1, 2022, the North American Veterinary Licensing Examination (NAVLE) is currently in the middle of a testing window, which goes until March. To ensure a smooth transition, the new process will not begin until the new testing window. The Board will work with AAVSB, ICVA and the schools to provide outreach to future applicants.

All AVMA accredited Veterinary Technician National Exam (VTNE) applications will be reviewed/approved by AAVSB. However, the Board will continue to review/approve alternate route applications. AAVSB has expressed a willingness to begin processing alternate route applications for the Board, but additional meetings will be necessary to ensure they are able to take on the additional workload without negatively impacting applicants.

Elimination of the California State Board Examination (CSBE).

Prior to January 1, 2022, there were approximately 150 applicants who met all licensing requirements except for the CSBE. Board staff proactively identified these applicants and manually waive the CSBE requirements. As of the date of this memo, 21 of those applicants have been licensed and 129 will be licensed as soon as they file their final license application.

104 applicants paid for the CSBE but did not complete the examination. Board staff is working with DCA's cashiering team to process the refunds, totaling \$33,600.

Licensing Updates

Renewal Requirements (Strategic Plan Objective 2.4)

As of December, licensees now receive automatic BreEZe notifications when a renewal payment is received, and the renewal is being held due to missing fingerprint results. As previously reported, this was a manual notification processes staff would perform each morning. This automation eliminates the manual process, providing faster notification to licensees.

BreEZe Updates (Strategic Plan Object 2.3)


Over the past few months, staff worked with OIS to update BreEZe to reflect AB 1535 improvements. Due to the significant system enhancements necessary to fully implement AB 1535 and the increased OIS workload attributed to other legislation, design updates are being completed in multiple phases in order of priority. All feerelated updates were launched in January. All other enhancements are scheduled to launch in February.

Performance Measures

Applications

Board applications decreased since the prior quarter, with 45% fewer veterinarian applications, 16% fewer RVT applications, 30% more veterinary premises applications, and 8% more VACSP applications compared to last quarter. The Board received 6 university license applications, down from 17 last quarter. The Board typically receives an increase in veterinarian applications because of NAVLE and CSB eligibility. The decrease in veterinarian applications can be attributed to the standard fluctuation from school graduations and applicants waiting for AB 1535 to take effect, which changes the requirements for examination and licensure eligibility. Similarly, RVTs now apply after they have met the requirements for licensure, which would increase our applications after examination results have been received. Compared to the same quarter last year, the Board received 4% less applications and issued 11% less licenses and permits.

As indicated in the chart below, veterinarian and VACSP applications continue to increase annually. The FY 19-20 RVT applications increase was likely due to the removal of the California RVT examination, applicants applying before the January 2020 fee increase, the RVT applications being reduced from two applications to one. The decrease from FY 19-20 to FY 20-21 for premises is most likely linked to the outbreak of COVID and office closures. Board staff will continue monitoring applications received and provide regular updates during Board meetings.



Most pending applications decreased since last quarter, but the pending veterinarian applications increased by 21%.

<u>Licenses</u>

Overall, the Board issued more licenses compared to last quarter. While the Board issued 56% less veterinarian licenses, RVT registrations increased 100%, premises registrations decreased 21%, and VACSP registrations increased by 69%. Additionally, there were 6 university licenses issued, a decrease of 12 from last quarter. Again, this overall increase in licenses issued corresponds to licensure requirements and examination results – specifically the VTNE for RVT.

As indicated in the chart below, the Board issued fewer veterinarian licenses FY 19-20 likely due to COVID and the reliance of graduation to obtain licensure. Similarly, there would be fewer reciprocity candidates seeking licensure as there was an abundance of caution through FY 20-21. With AB 1535 eliminating temporary and intern licenses, there may be a slight decrease in licenses issued in the following years, because those individuals will only apply for their permanent veterinarian license.
