

Kent Fowler, D.V.M. graduated from Salinas High School in 1969. During his high school years, Kent was a Monterey County 4-H All-Star and South Coast Region Future Farmers of America (FFA) President. He attended the University of California at Davis (UCD), receiving a B.S. in Animal Science and a Doctorate in Veterinary Medicine in 1977. At UCD, he was President of the Rodeo Club and Alpha Gamma Rho fraternity. He and his wife, Cindy, have been married 42 years. Cindy is a writer and a retired English, creative writing, and drama teacher. Their son, Josh, graduated from UCD with a BA in political science, spent three years in the Peace Corps in South Africa and is currently a writer and editor in Oakland, CA. Their daughter, Jaclyn, graduated from UC Santa Barbara and received a Master's in Marine Biodiversity and Conservation from Scripps Research Institute. Kent practiced large animal veterinary medicine, specializing in equine, in the tri-county central coast of California from July 1977 until January 2004.

In addition to a busy work schedule, Kent has a long history of leadership and dedication to public service. He is especially proud of his nine (9) year tenure as an elected trustee in the Washington Union School District in Salinas, CA.

Exercises independent scientific judgment in overseeing the conduct of the most complex work of disputed or controversial professional scientific issues. Promotes science-based methods to respond to animal disease emergencies, support sound food safety policy and promote the marketability of agricultural products. Provides leadership to develop and implement innovative and constructive preventive veterinary medicine concepts with consideration for future needs. Oversees effective disease intervention strategies and the control of movement of animals and products. Prevents transmission of food borne pathogens to humans by developing, in cooperation with the industry and other agencies, quality assurance plans and other strategies to enhance the safety of animal food products and stewardship of the environment. Establishes and maintains cooperative relations with professional staff and with officials of Federal, State, local, university and private research organizations to ensure timely detection and response to foreign and emerging diseases. Provides professional and scientific expertise to other agencies in the State to solve problems associated with zoonotic diseases detected in livestock and poultry such as avian influenza, bovine cysticercosis, bovine tuberculosis, bovine spongiform encephalopathy, Johne's Disease, rabies, and West Nile virus. Conducts effective outreach to educate and inform the public, partners and stakeholders about food safety, potential risks of emerging, foreign, and zoonotic livestock and poultry diseases, how to recognize and report them, and their role in disease control and/or eradication. Prepares scientific articles and scientific reports for publication related to the public health disease investigations such as bovine tuberculosis, avian influenza, bovine spongiform encephalopathy and Lyme disease. As President of Western States Livestock Health Association (2013), served as a spokesperson and scientific expert for regulatory animal diseases to include but not limited to the zoonotic diseases. Due to California's numerous equine, bovine and poultry disease outbreaks over the past decade, California's AHB has staff considered the nations' experts in disease control, thus the Branch Chief acts as a spokesperson in the scientific arena and participates in the development of national policy.

Sensitivity and complexity of the issue challenges regulatory officials across the country. Ultimately, the data and epidemiology identified risk factors for disease transmission were incorporated into the National Bovine Tuberculosis Control Plans. Communicated effectively to stakeholders to outline preventive biosecurity measures necessary to decrease the threat of public health diseases.



This is a letter of interest in seeking a reappointment as a veterinarian to the Multidisciplinary Advisory Committee (MDC) of the Veterinary Medical Board (VMB). As you know, I am very familiar with the MDC and know its purpose and how it functions. I enjoy doing the work of the MDC, which is to do the research, hold public meetings, get stakeholders involved in the discussion of an issue, and propose regulatory language when appropriate to address the issue that you gave us. To me, the most important aspect of this endeavor is to take an idea, either from the legislature, the public, or from the VMB and write regulations that fulfill the intent of the assignment and make it workable in a practice setting. We can have the best ideas in the world, but if we don't make them work at the clinical level, they are worthless and maybe even harmful.

We have a lot of issues to deal with as you can see from MDC 2022 Assignments Memorandum that you will have before each meeting. Many of these issues I have worked on while on the Board and on the MDC and I believe that I can help get them to completion. We are almost there with the new compounding regulation that will go into law on April 1st, that will literally allow veterinarians in California to continue to do clinical compounding. However, I believe a big task yet to be done is to develop educational material for the practitioner so that they can not only comply with the regulation, but to do it easily, in a straightforward way that is not cumbersome or complicated.

We still have the cannabis issues which is now even more complicated be the deregulation of hemp CBD. Now the new issue is that the active ingredient (CBD) is also made with marijuana, which is better controlled, tested, and regulated then the hemp CBD.

I could go on and on about MDC issues, but my ask is to be reappointed to the MDC. It would be a great honor and privilege for me to continue working on the MDC because I believe that I have some good information and research to offer the committee and the Board.

I hope that we all can get back in-person at the April meeting which I believe is a more effective way to conduct the type of business that the Board and the MCD does.
