2. Approve March 14, 2012 Meeting Minutes

- **Dr. Jon Klingborg motioned and David Johnson, RVT seconded the motion to approve the March 14, 2012 Meeting Minutes.**

3. Executive Officer Report

A. Board Program Reports

Ms. Geranen reported the Executive Officer and Board Program Reports are from the April Board meeting.

Ms. Geranen gave an overview of the Sunset Review process. The MDC requested copies of the Sunset Review Report. Ms. Geranen asked the MDC to forward any comments on the Report to staff by July.

Ms. Geranen reported MDC enforcement training will take place in October and the minimum standards rulemaking file is being prepared by staff for submittal to the Department of Consumer Affairs. Dr. Grant noted new minimum standards regulations will impact the newly developed Hospital Inspection Self Checklist.

Sandra Monterrubio reported veterinary premise inspector training will take place in September. Ethan Mathes reported the Hospital Inspection Self Checklist will be mailed out to all veterinary premises by the end of the summer.

The MDC reviewed and discussed amendments to the draft Citation and Fine Guidelines.

- **Dr. Richard Sullivan motioned and Dr. Jon Klingborg seconded the motion to keep the term “consultant” in the Citation and Fine Guidelines.**
- **The motion carried 6-0.**
- **David Johnson, RVT motioned and Dr. Jon Klingborg seconded the motion to amend Citation and Fine Penalty, number 13, Level A range to \$500 - \$2,000.**
- **The motion carried 6-0.**
- **Dr. Jon Klingborg motioned and David Johnson, RVT seconded the motion for staff to finalize all amendments to the Citation and Fine Guidelines, send the Guidelines to the Multidisciplinary Committee for their review and forward the amended Guidelines to the Veterinary Medical Board.**
- **The motion carried 6-0.**
- **Dr. Richard Sullivan motioned and Dr. Jon Klingborg seconded the motion to approve California Code of Regulations section 2043 as amended and forward to the Veterinary Medical Board.**
- **The motion carried 6-0.**

Dr. Grant noted staff will make any discussed changes to the Guidelines. Ms. Geranen added the Guidelines will be sent to the Board for review at their July or October meeting.

5. Discuss Animal Rehabilitation

A. Similar States' Animal Rehabilitation Language

B. Task Force Report and Model Language

Dr. James Syms noted animal rehabilitation is a burgeoning industry, human physical therapists seek to provide services to companion animals that include specialized training to ensure animal patient safety, and regular communication with veterinarians is important for case management in animal rehabilitation. He stated it is recognized that statutory authority would be required to allow physical therapists to provide animal rehabilitation.

Erin Troy spoke to her experience in operating an animal rehabilitation facility and that the Board should consider that animal rehabilitation is the practice of veterinary medicine, pain control is part of animal rehabilitation, and that integration between animal rehabilitation and veterinarians is important.

Jessica Waldman reported on her experience with working cooperatively with a licensed physical therapist and recommended to the Board that veterinarians work with animal rehabilitation personnel in the same practice due to the fact that veterinarians are an important part of proper diagnosis and are ultimately responsible for protecting the animal patients welfare.

Amy Kramer stated that she felt physical therapists were the preferred provider for animal rehabilitation and should work in collaboration with veterinarians.

The MDC discussed board certification of animal rehabilitation for physical therapists, the limits in veterinary law for animal rehabilitation by physical therapists, that animal wellness should be considered in any discussion of animal rehabilitation, and what kind of supervision is permissible for physical therapists.

Shela Barker, Legal Counsel, commented that the Board cannot limit the practice of veterinary medicine for veterinarians and that the level of supervision for physical therapists could not be less than it is for RVTs.

The MDC agreed that they prefer direct supervision for animal rehabilitation with the possibility of setting educational requirements in order to practice animal rehabilitation. The MDC discussed the place of registered veterinary technicians in animal rehabilitation and the appropriate level of supervision and responsibility. The MDC requested legal staff to draft proposed language for animal rehabilitation based on the MDC's discussion and refer the proposed language back to the MDC and any interested parties.

6. Update on Committee Member Enforcement Training - November 13-14, 2012

Ms. Geranen updated the MDC on plans for the enforcement training in November and to send any questions related to the training the Ms. Monterrubio.

7. Comments from Public/Outside Agencies/Associations

Ms. Geranen noted staff would advertise that the MDC is accepting applications for its vacancy due to Dr. Richard Sullivan's appointment to the Board. Staff will also post the advertisement on the Board's website.

2. Approve June 13, 2012 Meeting Minutes

- **Dr. Jon Klingborg motioned and Jennifer Boyle, RVT seconded the motion to approve the June 13, 2012 Meeting Minutes.**

Dr. Oscar Chavez brought up the discussion from June about animal rehabilitation and Shela Barker's comment about Physical Therapist's (PT) compared to Registered Veterinary Technician's (RVT) and that the supervision of a Physical Therapist must be at the RVT level or higher. Following discussion the item was tabled to the next meeting for clarification.

3. Executive Officer Report

A. Board Program Reports

Ms. Geranen reported the Sunset Review Report was delivered to the Legislature and is posted on the Board's website. Questions from the Senate Business & Economic Development Committee will come to the Board about two weeks prior to the sunset hearings sometime in March.

Ms. Geranen reported that staff is working on the RVT school approval regulations to be noticed in November for a public hearing in January.

Ms. Geranen reported there are seven months left to place license plate orders.

Paul Sanchez reported Monica Ochoa left the Board and is working for the California Highway Patrol. We will be interviewing for her replacement and recruiting to fill two other vacancies to handle the increase in the workload. The filing of complaints is on target to exceed 800 by the end of this fiscal year. Eighty-four cases are at the Office of the Attorney General

Dr. Jon Klingborg brought up discussion on AB 1839. The MDC, Dr. Kendall, Val Fenstermaker, and Nancy Ehrlich spoke about what "access" means, main supply versus daily use, who the law extends to, when will information be in writing, background check versus livescan. The MDC sent this back to the Board.

Ms. Geranen spoke about the complaint process. The MDC reviewed and discussed amendments to the final draft Citation and Fine Guidelines and Regulations.

5. Discuss Animal Rehabilitation

James Dagostino, PT, asked if Animal Rehabilitation (AR) was defined in law. Rebecca Bon stated AR is considered the practice of veterinary medicine as noted in Business and Professions Code (B & P) section 4826(c).

Dr. Grant stated that his concerns for Physical Therapists performing AR include the fact that animals and humans are anatomically different. He was also concerned about the topical medicine that PT's are allowed to use in human medicine

Jennifer Boyle, RVT, stated RVT's should be allowed to perform PT duties on animals. Ms. Erlich noted they already are per California Code of Regulations sections 2036.5(b) and 2038.

Dr. Grant noted AR is not a restricted RVT duty at this time. He suggested AR is a starting point where PT's are working together with veterinarians under direct supervision.

Mr. Dagostino, PT, noted not all PT's should be allowed to work on animals and there should be specialized training to do so. Ms. Boyle, RVT, suggested a special certification for AR.

Dr. Chavez stated licensed PT's should have advanced training and potentially hold dual RVT/PT licenses to perform AR. He also noted direct supervision is not always practical.

Dr. Klingborg stated that in his opinion the Board should start with the foundation of PT's working under direct supervision and look at indirect supervision in the future because emergencies can occur. He noted that RVT's were left out of the chiropractic regulations, but DVM's, RVT's and PT's should be included in the AR regulations.

Diann Sokoloff stated the accountability and responsibility for the animal patient would still be with the veterinarian's even under indirect supervision.

- **Dr. Jon Klingborg motioned and Jennifer Boyle, RVT seconded the motion to adopt the CVMA's proposed Animal Rehabilitation language as amended.**

Discussion ensued between the MDC, the PT representatives and the audience.

• **Motion Withdrawn**

- **Dr. Jon Klingborg motioned and Jennifer Boyle, RVT seconded the motion to adopt Animal Rehabilitation language as amended and forward to the Veterinary Medical Board.**

Mr. Dagostino, PT recommended more liberal supervision.

Dr. Grant elected to defer the discussion of Electronic Record Keeping to the next MDC meeting in March 2013.

The MDC discussed telemedicine and the issue was deferred to the next MDC meeting in March 2013.

The MDC discussed faculty licensure which could convert to a California license. Ms. Erlich suggested a veterinarian wanting to convert a faculty license to a California license should take the veterinary law exam at a minimum to convert. It was recommended that representatives from University of California at Davis and Western University be invited to the next MDC meeting in March 2013.

7. Comments from Public/Outside Agencies/Associations

Dr. Grant informed there is a vacant MDC position. For those interested in applying for the MDC position, submit candidate information to the Board for review at the January meeting.
