Veterinary licensees with a "Retired" status who wish to reinstate their license back to "Current."

Pay Required Fees and Submit Required Documentation

Verification of completion of thirty-six (36) hours of approved continuing education (CE)**

If your license has been in "Retired" status for less than five (5) years, you may reactivate your license using this application.

If your license has been in "Retired" status for more than five (5) years, you must apply for licensure using the 4902 Initial Veterinary Application.

**Completion of thirty-six (36) hours of approved CE must be in the two years immediately preceding the date your application to reactivate your license was submitted.

Information Privacy Act

Failure to provide any of the requested information will result in the application being deemed incomplete.
