<b>SUBJECT</b>	<b>Agenda Item 10A. Status Update on Pending Regulations</b>

The Veterinary Medical Board (Board) currently has 17 regulatory packages that are pending the regulatory process. Eleven of those packages have been submitted and are in various stages of the initial or final phase, as identified on the attached document. The remaining 6 packages are pending development from the Lead Administrative and Policy Analyst before submission or are pending Board approval.

Changes since the October 2019 Board meeting include the following:

- Emergency Fee Increase – Approved**  
The emergency fee rulemaking package was approved by Office of Administrative Law on January 27, 2020 and filed with the Secretary of State. The emergency fee increase became effective the day of approval. In order for the fee increase to remain permanent, the Board must submit the packet through the regular rulemaking process and file a Certificate of Compliance by July 24, 2020.
- Consumer Protection Enforcement Initiative (CPEI) – Revised and Resubmitted**  
The Office of Administrative Law (OAL) requested minor technical revisions. Those revisions were made and the package was resubmitted to OAL on November 20. The Office of Administrative Law (OAL) approved the CPEI rulemaking file on December 30. It will become effective on April 1, 2020.
- AB 2138 (Substantial Relationship and Rehabilitation Criteria) - Withdrawn**  
Due to multiple substantive concerns with the proposed regulatory text raised by the Office of Administrative Law (OAL), I had to officially withdraw our AB 2138 rulemaking package on November 19. As you may recall, this proposal was a collaborative effort from DCA, OAL, and the Attorney General’s office (AG), and we were the first DCA board to submit our package to OAL for review. After the package was withdrawn, DCA’s Legal Affairs Division worked on options to address OAL’s concerns. The Board will be discussing the proposed solutions during Agenda Item 10D.

- **Telemedicine - Approved**

The rulemaking packet was approved by OAL on November 27 and became effective on January 1, 2020.

- **VCPR Informed Consent – Need to Readopt**

Now that the Telemedicine rulemaking is approved by OAL, I recommend revisiting the VCPR Informed Consent proposal. When the Board approved this proposal at the January 2019 meeting, it was aware of the Telemedicine proposal moving through the rulemaking process and had that language in the meeting materials. We believe it is best to bring the Informed Consent proposal back to the Board. Agenda Item 10D further discusses this and requests the Board readopt the revisions to the regulation following enactment of the Telemedicine provisions. This would make it cleaner for OAL review.

- **Animal Physical Rehabilitation – Submitted to the Director**

The Legal Affairs Division approved the APR rulemaking and submitted to the Director on January 10, 2020. After approval, it will go to Agency for review/approval. Then, it will be publicly noticed and the 45-day public comment period will begin.

### **Rulemaking Calendar**

Government Code section 11017.6 requires every state agency responsible for implementing a statute that requires interpretation pursuant to the Administrative Procedure Act to prepare, by January 30, a rulemaking calendar for that year.

The rulemaking calendar must be (1) prepared in accordance with the format specified by the Office of Administrative Law (OAL), (2) approved by the head of the department or, if the rulemaking agency is an entity other than a department, by the officer, board, commission, or other entity which has been delegated the authority to adopt, amend, or repeal regulations, and (3) published in the California Regulatory Notice Register (Notice Register). (Government Code, section 11017.6.)


Attached is the Board's rulemaking calendar submitted by the Board. The format for the rulemaking calendar has changed in order to be ADA compliant.

## Status of Pending VMB Regulations


### Emergency Fee Increases



**CCR Section:** 2070, 2071

**Notes:** The Board approved emergency and general rulemaking on 10/9/19. The package was submitted for pre-review on 10/17/19. On 10/25/19, the package was submitted to DCA for concurrent Legal Affairs and Budget review; both units approved the package on 11/19/19. Director approved package on 12/30/19, and it was submitted to Agency on 12/31/19 and approved on 1/9/20. The Board published its Notice of Intent to File on January 10, 2020, and OAL initiated the five-day public comment period on January 17, 2020. OAL approved the rulemaking and filed it with the Secretary of State on January 27, 2020, effective immediately.

### Consumer Protection Enforcement Initiative (CPEI)



**Notes:** The CPEI rulemaking package was originally submitted through DCA for review in 07/2017, but due to recommendations received from Legal Affairs, the package was returned to the Board and amendments were made to the proposed language effective 02/2018. The rulemaking package was re-submitted to DCA for review effective 05/02/2018. Comments and recommendations were received from Agency and the Board amended the proposed language at the 01/2019 meeting. The package was noticed by OAL on 03/08/2019 and the 45-day comment period closed on 04/22/2019. The final rulemaking package was submitted to OAL for review on 06/24/2019. Due to comments received from OAL, this package was withdrawn on 08/02/2019. An addendum to the Initial Statements of Reasons was submitted and a 15-day notice was published on 08/21/2019 and the comment period closed on 09/05/2019. The addendum to the package was resubmitted to DCA on 09/09/19. The package was submitted to Agency on 09/24/2019 and approved on 11/7/2019. The package was resubmitted to OAL on 11/20/19 and approved/filed with Secretary of State on 12/30/19. The revised regulation is effective April 1, 2020.


### Telemedicine

**Notes:** The Telemedicine proposed language was approved in [04/2015](#) and then amended in [02/2018](#). The rulemaking package has been submitted to DCA for review effective 05/14/2018. The package was noticed by OAL on [05/17/2019](#) and the 45-day comment period closed on 07/01/2019. The final rulemaking package was submitted to DCA effective 08/05/2019. The package was submitted to Agency on 09/03/2019 and approved on 10/9/19. The Final package was submitted to OAL on 10/15/19 and approved by OAL and filed with Secretary of State on 11/27/19. The effective date is 1/20/20.

### stantially Related Criteria Regarding Criminal Convictions



**Notes:** This regulation was approved by the Board at the [01/2019](#) meeting. This regulatory proposal is mandated by [AB 2138](#) (Chiu, Chapter 995, Statutes of 2018) and must be implemented by 07/01/2020. The package was submitted to OAL on 06/17/19 and noticed on [06/28/19](#). The 45-day comment period closed on 08/12/19. The final rulemaking package was submitted to DCA effective 08/15/2019. The package was submitted to Agency on 08/28/2019 and approved 10/2/19. The Final package was submitted to OAL on 10/9/19; on 11/18/2019, OAL raised concerns which ultimately led to EO withdrawing rulemaking on 11/20/19. 1/30/20 possible Board review of revised text.

Three taskforce meetings were held to discuss this issue ([06/2016](#), [10/2016](#), [02/2017](#)). In [10/2017](#) the Board approved proposed language. **The rulemaking package was submitted to DCA for Legal Affairs and Budget concurrent review on 03/27/2019; Budgets approved on 9/10/19. Legal Affairs approved the package on January 10, 2020 and submitted it to the Director for review.**







The rulemaking package **was submitted to DCA for Legal Affairs and Budget concurrent review** on 04/03/2019 **and is still pending.**

### Veterinarian-Client-Patient Relationships (VCPRs)



**Notes:** VCPRs was originally included with Telemedicine and Minimum Standards and approved at the [04/2015](#) meeting, but a byproduct of separating the Telemedicine from Minimum Standards cause the VCPRs to be dropped off. The language was re-presented to the Board at the [08/2018](#) meeting where additional changes were approved. The rulemaking package was submitted to DCA **for Legal Affairs and Budget concurrent review** on 04/10/2019 **and is still pending.**



### Shelter Minimum Standards




### erinary Student Exemption/RVT Exam Eligibility

The Board briefly reviewed the proposed language at the [04/2019](#) meeting and approved the proposed language at the [07/2019](#) meeting.

### CPR/Informed Client Consent



**Notes:** The VCPR/Informed Client Consent proposed regulations was presented as a question from the MDC regarding the requirements of a veterinarian to advise clients about dental radiographs at the [11/2018](#) meeting. The Board reviewed this at the [01/2019](#) meeting and decided to proceed with regulatory amendments. This regulatory package **was held** pending the approval of the Telemedicine regulations. **The Board will review/approve the proposal with telemedicine language update during the 1/30/20 meeting.**

As discussed at the [11/2018](#) meeting, DCA is reviewing the Uniform Standards of other healing arts Boards and it was recommended to hold off on developing the regulatory package until DCA has completed their review and recommendations. At the [01/2019](#) meeting, the Board created a subcommittee to look at Uniform Standards further. At the [04/2019](#) meeting the subcommittee provided a brief update on the Uniform Standards and at the 09/12 teleconference the Board voted to proceed with a new trigger. **The Board approved revised language on 10/9/19.**
