As of July 1, 2020, the Veterinary Medical Board (Board) has one <u>veterinarian</u> position and one <u>RVT</u> position to fill on its nine-member Multidisciplinary Advisory Committee (MDC). The term for these positions begins upon appointment and goes through June 30, 2023.

The veterinarian position was previously held by Jeff Pollard, DVM, who has termed out. The RVT position is currently held by Leah Shufelt, and she is eligible for reappointment to a second three-year term.

The vacant positions were posted on the Board's website and emailed to the Board's electronic notification subscribers. The Board received 11 veterinarian applications and seven RVT applications. After a thorough review, the Board's Executive Committee conducted eight virtual interviews and selected the following top four candidates (two per position) for Board consideration:

To whom it may concern,

I am writing to express my interest in the open position on the Veterinary Medical Board Multi-Disciplinary Committee. I have been a licensed veterinarian in California since graduation from the UC Davis School of Veterinary Medicine in June 1980. I was engaged in both small animal and large animal (equine and livestock) private practice for three decades both as an employee and a practice owner. Since 2011 I have been associated with the veterinary medical board primarily as an in-house consultant providing consumer complaint reviews. During that time, I also provided hospital inspections both routine and complaint-related, training for veterinary board administrative staff and other inspectors, as well as providing expert witness testimony in formal disciplinary cases. I have been a member of the board's Diversion Evaluation Committee for the past five years and currently am the chairperson of that committee. Since 2015 I have been employed full time at the UC Davis School of Veterinary Medicine in the Academic Programs Department. I instruct in a variety of small and large animal clinical courses as well as overseeing the live animals used for teaching at the school. In addition, I teach the Jurisprudence course to the third-year veterinary students, successful completion of which exempts them from the laws and regulations examination for licensure. I also provide all of the regulatory content for the Temporary Licensing Curriculum course that is administered by the School of Veterinary Medicine to all new faculty and house officers who require California licensing for their positions at the school. My background, experience and current professional activities, as well as my long relationship working within the veterinary board, provide a strong foundational knowledge of both the profession and its needs, as well as the regulatory oversight provided by the board and mandated by the state. I have included a current CV as well as a letter of reference from the Associate Dean of Professional Education who is currently my direct supervisor at the School of Veterinary Medicine. This is my statement of understanding regarding the role that the Multidisciplinary Advisory Committee (MDC) holds within the Veterinary Medical Board.

I am aware that the Veterinary Medical Board (VMB) is one of the many boards that operate within the Department of Consumer Affairs. It's composition includes four California licensed veterinarians, one Registered Veterinary Technician, and three public members. Members of the VMB are appointed by the Governor and the legislature, and the highest priority of the Board is the protection of the public.

The MDC is a nine member group created by the legislature that works to assist the VMB. It is composed of five California licensed Veterinarians, three Registered Veterinary Technicians and one public member appointed by the VMB. One Veterinarian and one Registered Veterinary Technician must be Board members.

It is the MDC's duty to research issues assigned by the VMB. They have discussions to determine if these changes or suggestions would make a sufficient improvement to warrant a change to regulation or statute in order to protect the consumer and ensure that the licensees are maintaining their professional standards.

I understand that the statutes are the laws that are determined by the legislature, and that the regulations written by the Veterinary Medical Board are meant to fill in the more ambiguous parts of the laws. The California Veterinary Medicine Practice Act contains all of the statues and regulations having to do with the practice of veterinary medicine in CA.


