#### **Licensing Unit Staff Update**

On November 23, 2020, Melissa Caudillo and Jennifer Tarrant, the Board's licensing technicians for Veterinary Assistant Controlled Substance Permits (VACSPs) and registered veterinary technicians (RVTs), accepted promotions within the Board's Enforcement Unit. Recruitment efforts are underway to fill those vacant licensing technician positions.

### **<u>Licensing Customer Survey</u>** (Strategic Plan Objective 3.2)

Licensing Unit staff began utilizing the new licensing customer satisfaction survey as part of their signature blocks. To date, the Board has received 21 responses, most indicating difficulty reaching staff and poor staff responsiveness. Staff have discussed responses and will continue to follow up with the survey link for additional feedback.

#### **Renewal Requirements** (Strategic Plan Objectives 2.2 and 2.4)

With the increased pandemic numbers, the Board continues to receive inquiries regarding the fingerprint and continuing education (CE) requirements for licensure renewal. Most of the inquiries express frustration with the current pandemic guidelines on the fingerprint requirement.

The Board continues to send monthly informational email blasts to all stakeholders. The information includes important information regarding Board actions, and programmatic and waiver updates.

### <u>California State Board Examination</u> (Strategic Plan Objective 2.3)

Strategic Plan Objective 2.3 seeks to increase access to veterinary care, which includes analyzing existing licensure requirements, including clinical practice hours and eliminating unnecessary barriers to licensure. Following the Board's vote at its October 22-23, 2020 meeting to eliminate the California State Board Examination, Board staff analyzed veterinarian licensure requirements and have made recommendations as identified in Agenda Item 8.

#### **Continuing Education Audit**

The Board has reallocated one of its existing administration positions to support the continuing education (CE) audit program. The staff member sends out letters to randomly selected licensees, who must submit to the Board documentation of their compliance with CE requirements in accordance with California Code of Regulations, title 16, section 2085.9. Citations will be issued to those not in compliance with the regulation.

#### **Licensing Unit Performance Measures**

#### **Applications**

The Board has seen a decrease from the prior quarter in the number of applications received. The Licensing Unit received 2% fewer veterinarian applications, 47% fewer university veterinarian applications, 42% fewer RVT applications, 17% fewer premises registrations, and 20% fewer VACSP applications compared to last quarter.

Additionally, the number of licenses issued as compared to last quarter has decreased overall. The licenses issued for veterinarians decreased by 57%, university licenses decreased 38%, and RVT licenses decreased 13%. However, there was a 13% increase in premises registrations and 32% increase in VACSPs issued.

Board staff are making progress working on pending applications, with a majority of the pending applications decreasing from the last report. The pending veterinarian applications have increased due to staffing shortages.

### <u>Processing Times and Pending Applications</u> (Strategic Plan Objective 2.1)

Strategic Plan Objective 2.1 intends to "[d]ecrease licensure processing times by issuing a license to any candidate who completes the licensure requirements within 4 weeks to increase consumer access to veterinary care and to increase candidate access to licensure." As demonstrated in the attached statistics, the average cycle time to process veterinarian license applications is 15 days, which exceeds the 28-day goal.

#### **Increased BreEZe Usage** (Strategic Plan Object 2.3)

As demonstrated in the attached Monthly Application Statistics report, paper applications for most license types have dramatically decreased. Over the last year, all applicants and licensees have been encouraged to use BreEZe when applying and renewing licenses. All veterinarian, university license, RVT, and temporary license paper applications have been removed from the Board's website. Premises registration and VACSP paper applications will be removed shortly. This transition to electronic license application submission and processing not only streamlines the process for applicants, licensees, and licensing staff, but it also significantly reduces physical mail received and processed through cashiering and front office staff.
