As of January 28, 2021, the Veterinary Medical Board (Board) has one <u>public</u> position to fill on its nine-member Multidisciplinary Advisory Committee (MDC). The term for this position begins upon appointment and goes through June 30, 2024. The public position was previously held by Stuart Eckman, who is no longer a California resident.

The vacant position was posted on the Board's website and emailed to the Board's electronic notification subscribers. The Board received four applications. However, after consulting with Department of Consumer Affair's Legal Affairs Division, it was determined that three applicants did not qualify as public members pursuant to Business and Professions Code section 450 et seq. One of those three also was disqualified due to conflicts of interest pursuant to Government Code section 87104.

Therefore, the Executive Committee has selected the remaining candidate, Maria Salazar Sperber, JD, to be interviewed by the Board during the January 28, 2021 Board meeting. Ms. Sperber's Application Packet is attached for Board consideration.

Dear Ms. Sieferman and Mr. Rodda,

Thank you for the opportunity to apply for appointment to the Veterinary Medical Board Multidisciplinary Advisory Committee as a public member. My experience as a public member on the California Board of Optometry, a legislative advocate in a heavily regulated environment and a member of a community non-profit supporting vulnerable populations gives me the ability to evaluate situations in a reasonable, thoughtful manner; therefore, a valuable member of the advisory committee.

As a member of the Board of Optometry from 2016-2020, I had the opportunity to serve with those passionate about improving the consumer experience and improving safety guidelines, while supporting optometric students seeking licensure and professional optometrists. It was an honor to share ideas, debate consumer protection issues and watch our board move forward with legislation aimed at increasing eye exams in our children and older adults. As a member of the legislative and regulation committee, as well as the public outreach committee, we cultivated a very robust legislative agenda and strategic plan. Further, we debated recommended rules and regulations, including topics such as telemedicine, fee structures, application processes and continuing education requirements, to further the practice of optometry and provide access to care for Californians. Participating on the Board of Optometry enriched my understanding of board operations and regulatory enforcement.

During the COVID-19 pandemic, my position with the California Hospital Association necessitates frequent interaction with the Department of Consumer Affairs. As key members of the health care community, hospitals made requests for regulatory waivers to facilitate the care of COVID-19 patients and address workforce shortages. Understanding the vital roles our physicians, nurses, respiratory therapists, pharmacists, and many other regulated workforce partners play in responding to the pandemic, on balance with protecting California consumers, gives me another perspective of the inner workings of the Department of Consumer Affairs. Balancing regulatory requirements to ensure the safety of our patients and providing regulatory guidance to California employers can be challenging, especially during a pandemic; however, pragmatic, clear leadership can make a difference for consumers and employers alike.

Since 2012, I have served on the Friend of the Crisis Nursery board (President from June 2014-2016; 2019-current), an auxiliary of the Sacramento Children's Home. Our mission is to support the Sacramento County Crisis Nursery Program, which provides emergency childcare to families and caregivers in crisis. Whether it be homelessness, mental illness, parental stress or a family emergency, the crisis nurseries provide a safety net for children ages 0-5 in a safe, loving environment so their families and caregivers can manage their crisis. While First 5 supports the nurseries to some extent, our program is largely funded by private donations: whether it be in-kind donations, volunteering at the nurseries or raising money to pay our staff. Since 2012, our board has raised over \$750,000 to support the Sacramento Children's Home Crisis Nursery Program. Working with a non-profit to provide safety net services to vulnerable families within Sacramento County has been a wonderful opportunity to improve the lives of children and their caregivers.

It would be an honor to serve as a public member on the Veterinary Medical Board Multidisciplinary Advisory Committee. My varied experience would make me a strong committee member who has an appreciation for new and current licensees, while also maintaining proper administration and enforcement of rules and regulations to protect our consumers.
