If a party or party's witness does not proficiently speak or understand the English language and before commencement of the hearing requests language assistance, an agency subject to the language assistance requirement in section 11435.15 of the Government Code shall provide a certified interpreter or an interpreter approved by the administrative law judge conducting the proceedings. The cost of providing the interpreter shall be paid by the agency having jurisdiction over the matter if the administrative law judge or hearing officer so directs, otherwise by the party for whom the interpreter is provided. #### **CONTINGENCY**

This stipulation shall be subject to approval by the Veterinary Medical Board. 4 5 Respondent understands and agrees that counsel for Complainant and the staff of the Veterinary Medical Board may communicate directly with the Board regarding this stipulation and 6 7 settlement, without notice to or participation by Respondent or her counsel. By signing the stipulation, Respondent understands and agrees that she may not withdraw her agreement or seek 8 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails 9 10 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal 11 action between the parties, and the Board shall not be disqualified from further action by having 12 considered this matter. 13

#### **DISCIPLINARY ORDER**

IT IS HEREBY ORDERED that Veterinarian License No. 9593 issued to Respondent Suzanne Kay Hanson is revoked. However, the revocation is stayed and Respondent is placed on probation for five (5) years on the following terms and conditions.

1. Obey All Laws.

6 Respondent shall obey all federal and state laws and regulations substantially related to the practice of veterinary medicine. Within thirty (30) days of any arrest, Respondent shall notify the Board. Within thirty (30) days of any conviction, Respondent shall report to the Board and provide proof of compliance with the terms and conditions of the court order including, but not 10 limited to, probation and restitution requirements.

Quarterly Reports and Interviews 2.

12 Respondent shall report quarterly to the Board or its designee, under penalty of perjury, on forms provided by the Board, stating whether there has been compliance with all terms and 13 conditions of probation. Omission or falsification in any manner of any information on these 14 15 reports shall constitute a violation of probation and shall result in the filing of an accusation 16 and/or a petition to revoke probation against Respondent's license, registration or permit. If the 17 final written quarterly report is not made as directed, the period of probation shall be extended until such time as the final report is received by the Board. Any period(s) of delinquency in 18 19 submission of reports as directed may be added to the total period of probation.

3. Interview with the Board

Within 30 days of the effective date of the Decision, Respondent shall appear in person for 21 22 an interview with the Board or its designee to review the terms and conditions of probation. 23 Thereafter, Respondent shall, upon reasonable request, report or appear in person as directed.

other reports similar in nature, as requested and directed by the Board or its designee.
Respondent is encourage to contact the Board's probation monitoring program representative at
any time she has a question or concern regarding her terms and conditions of probation.

5. Probation Monitoring Costs

Probation monitoring costs are set at a rate of \$100 per month for the duration of the
probation. These costs shall be payable to the Board on a schedule as directed by the Board or its

Respondent shall notify the Board, and appointed probation monitor, in writing of any and
all changes of employment, location and address within fourteen (14) calendar days of such
change. This includes, but is not limited to, termination or resignation from employment, change
in employment status, and change in supervisors, administrators or directors. Respondent shall
also notify her probation monitor IN WRITING or any changes in residence or mailing address
within fourteen (14) calendar days. Post Office Boxes are accepted for mailing purposes;
however, Respondent must also provide her physical residence address as well.

7. No Supervision of Students, Interns, or Residents

Respondent shall not supervise students, interns, or residents.

8. Notice to Employers

During the period of probation, Respondent shall notify all present and prospective
employers of this Decision and the terms, conditions, and restrictions imposed on Respondent by
Decision, as follows:

Within thirty (30) days of the effective date of this Decision and within fifteen (15) days of
Respondent undertaking any new employment, Respondent shall cause her supervisor and/or

managing licensee (licensee manager) to report to the Board in writing, acknowledging that the listed individual(s) has/have read Decision, including the terms, conditions and restrictions imposed. It shall be Respondent's responsibility to ensure that her supervisor and/or licensee manager submit timely acknowledgement(s) to the Board.

5 Relief veterinarians shall notify employers immediately and require the supervisor and/or
6 licensee manager to submit timely acknowledgement.

9. Notice to Employees

8 Throughout the probationary period, and in a manner that is visible to all licensed,
9 registered, or permitted veterinary employees at the veterinary premises, Respondent shall post a
10 notice, provided or approved by the Board, that recites the violations for which Respondent has
11 been disciplined and the terms and conditions of probation.

10. Tolling of Probation

Respondent shall notify the Board or its designee in writing within fifteen (15) calendar
days of any periods of non-practice lasting more than thirty (30) calendar days and shall notify
the Board or its designee within fifteen (15) days of Respondent's return to practice. Any period
of non-practice will result in the Respondent's probation being tolled.

Non-practice is defined as any period of time exceeding thirty (30) calendar days in which
Respondent is not engaging in the practice of veterinary medicine in California. While tolled for
residing/practicing outside of California, Respondent must comply with the following terms and
conditions of probation: obey all laws, quarterly reports, interview with the Board, tolling of
probation, maintain a current and active California license or registration, and cost recovery.

Non-practice is also defined as any period that Respondent fails to engage in the practice of
veterinary medicine in California for a minimum of 24 hours per week for the duration of
probation (except reasonable time away from work for vacations, illnesses, etc.) or as determined
by the Board. While tolled for not meeting the hourly requirement, Respondent shall comply
with all terms and conditions of this Decision.

11. Maintain a Valid License

At all times while on probation, Respondent shall maintain a current and active license with

the Board, including any period during which suspension or probation is tolled. If Respondent's license, by operation of law or otherwise, expires, upon renewal, Respondent's license shall be subject to any and all terms of this probation not previously satisfied.

12. Violation of Probation

If Respondent violates probation in any respect, the Board, after giving Respondent notice 5 and the opportunity to be heard, may revoke probation and carry out the disciplinary order that 6 was stayed. If an accusation or petition to revoke probation is filed against Respondent during 7 probation, or if the Attorney General's office has been requested to prepare any disciplinary 8 action against Respondent's license, the Board shall have continuing jurisdiction until the matter 9 is final, and the period of probation shall be extended until the matter is final. No petition for 10 modification or termination of probations shall be considered while there is an accusation or 11 petition to revoke probation pending against Respondent. 12

13. License Surrender While on Probation/Suspension

14 Following the effective date of this Decision, should Respondent cease to practice veterinary medicine due to retirement or health issues, or be otherwise unable to satisfy the terms 15 and conditions of probation, Respondent may tender her license to practice veterinary medicine to 16 the Board for surrender. The Board or its designee has the discretion to grant the request for 17 surrender or to take any other action it deems appropriate and reasonable. Upon formal 18 19 acceptance of the license surrender, Respondent will no longer be subject to the terms and conditions of probation. The surrender constitutes a record of discipline and shall become a part 20 of the Respondent's license history with the Board. 21

Respondent must relinquish her license to the Board within ten (10) days of receiving
notification from the Board that the surrender has been accepted.

14. Completion of Probation

All costs for probation monitoring and/or mandatory premises inspections shall be borne by Respondent. Failure to pay all costs due shall result in an extension of probation until the matter is resolved and costs paid or a petition to revoke filed. Upon successful completion of probation and all payment of all fees due, Respondent's license will be fully restored.

15. Cost Recovery and Payment of Fines

Pursuant to Section 125.3 of the California Business and Professions Code, within thirty (30) days of the effective date of this Decision, Respondent shall pay to the Board its enforcement costs including investigation and prosecution in the amount of \$1,717.50 or in a Board-approved payment plan, within six (6) months before the end of the probation term. Cost recovery will not be tolled.

#### 16. Rehabilitation Program – Alcohol or Drug

8 Within thirty (30) days of the effective date of this decision, Respondent shall submit in 9 writing a(n) alcohol/drug rehabilitation program in which Respondent shall participate (for the 10 duration of probation/for one/for two years) to the Board for its prior approval. Respondent shall 11 provide documentary evidence in the quarterly reports to the Board of continuing satisfactory 12 participation in this program. All costs shall be borne by Respondent.

Components of the treatment contract shall be relevant to the violation and to the Respondent's current status in recovery or rehabilitation. The components may include, but are not limited to: restrictions on practice and work setting, random biological fluid testing, abstention from drugs and alcohol, use of worksite monitors, participation in chemical dependency rehabilitation programs or groups, psychotherapy, counseling, psychiatric evaluation, and other appropriate rehabilitation or monitoring programs. All costs of participating in the program(s) shall be borne by the Respondent.

17. Submit to Drug Testing

Respondent shall immediately submit to drug testing, at Respondent's cost, upon request by
the Board or its designee. There will be no confidentiality in test results; positive test results will
be immediately reported to the Board and to Respondent's current employer.

Respondent shall make daily contact as directed by the Board or its designee to determine if she must submit to drug testing. Respondent shall submit to drug testing on the same day that she is notified that a test is required.

Any confirmed positive test for alcohol or any drug not lawfully prescribed by a licensed
practitioner as part of a documented medical treatment shall result in a cease practice order

resulting in a period of nonpractice/suspension from work by Respondent and may be a cause for revocation of probation. Respondent may not resume the practice of veterinary medicine in any form until notified by the Board in writing.

18. Abstain from Controlled Substances

Respondent shall completely abstain from the personal use or possession of controlled substances, as defined in the California Uniform Controlled Substances Act (Health and Safety Code section 11000 et seq.), and dangerous drugs as defined in Business and Professions Code Section 4022, except for medication lawfully prescribed to Respondent by a licensed practitioner for a bona fide illness. Upon request of the Board or its designee, Respondent shall provide documentation from the licensed practitioner that the prescription for the drug was legitimately issued and is a necessary part of Respondent's treatment.

To Whom it May Concern:

This office represents Suzanne Hanson, DVM in her efforts to petition the Veterinary Medical Board of California ("Board") for termination of probation. Dr. Hanson has been a licensed veterinarian practicing in Northern California for almost thirty-five (35) years. Dr. Hanson's veterinarian license was revoked, revocation stayed, and placed on a 5-year period of probation in Case No. 4602018000478 effective September 25, 2019. The stayed revocation and placement on probation is the lone disciplinary action against Dr. Hanson in more than three decades of her practice as a veterinarian.

The Board took this disciplinary action following Dr. Hanson's February 21, 2018 misdemeanor conviction for violating Vehicle Code section 23152(a) (driving under the influence of alcohol). The arrest underlying that conviction occurred on or about November 21, 2017. Dr. Hanson had not previously suffered an arrest or conviction nor has she since suffered an arrest or conviction. Dr. Hanson complied with the conditions of her 3-year period of criminal probation and as is evidenced by Exhibit H attached hereto, on January 14, 2022, the Sutter County Superior Court dismissed the conviction from Ms. Hanson's criminal record.

Dr. Hanson is now sixty-four (64) years old and in her narrative statement attached hereto as Exhibit B, fully acknowledges her alcoholism along with the personal and professional triggers that led her down the path of addiction. As is further detailed in Dr. Hanson's attached statement, although she suffered a setback following her completion of a 30-day residential treatment program, she has now maintained her sobriety since her probation began over two and one half (2 ½) years ago. That sobriety is verified by licensed marriage and family therapist and certified alcohol and drug counselor Francine Farrell, a letter from whom is attached hereto as Exhibit C. As she writes in her letter, Ms. Farrell monitors Dr. Hanson's recovery as the area administrator for the Pacific Assistance Group ("PAG"), the program Dr. Hanson chose to satisfy the probation condition requiring her to enroll in an alcohol or drug rehabilitation program. As Dr. Hanson writes in her narrative statement, she intends to continue her participation in PAG irrespective of the Board's decision on her petition to terminate the remaining balance of her probation.

Dr. Hanson is petitioning the Board for termination of probation for a multitude of reasons. First, she has a strong recovery program to prevent relapse, and thus formal monitoring by the Board is no longer necessary to ensure public safety. Second, as she is approaching retirement, she would like the freedom to travel internationally, something she has been unable to do while on probation. Third, she would like to work less than the required hours of practice contained in the 10<sup>th</sup> provision of her probationary agreement. Fourth and most seriously, is the unfortunate reality that Dr. Hanson was recently diagnosed with metastatic breast cancer for which she will be facing multiple doctor appointments, diagnostics and treatments for the foreseeable future. This uncertainty in her availability is likely to conflict with the Board's testing requirements and has also caused Dr. Hanson to reflect upon how best to prioritize her time between working the minimum hours required of her in her probation agreement or instead maximizing time with her loved ones.

Dr. Hanson's recovery journey has not been entirely seamless. However, it is evident when reviewing the attached materials that Dr. Hanson has appropriate insight into her struggles, her failures, and what ultimately allowed her to fully embrace not just abstinence, but true recovery. Upon application of the relevant statutes and regulations governing the criteria for rehabilitation and petitions for termination of probation, the Board will be assured that granting Dr. Hanson the relief requested herein would pose no risk of harm to the public.

#### Burden and Rehabilitation Criteria:

Dr. Hanson bears the burden of establishing her fitness for early termination of probation and must do so by clear and convincing evidence.<sup>1</sup> "The courts have defined clear and convincing evidence as evidence which is so clear as to leave no substantial doubt and as sufficiently strong to command the unhesitating assent of every reasonable mind. It has been said that a preponderance calls for probability, while clear and convincing proof demands a high probability."<sup>2</sup>

Business and Professions Code § 4887 provides, in relevant part, that a person whose license or registration has been placed on probation may petition the Board for early termination of probation after at least two years of probation when the probation ordered was that of three years or more.<sup>3</sup> The petition "shall be accompanied by at least two verified recommendations from veterinarians licensed by the board who have personal knowledge of the activities of the petitioner since the disciplinary penalty was imposed."<sup>4</sup> The petition shall not be considered while the petitioner is under sentence for any criminal offense, including any period during which the petitioner is on court-imposed probation or parole.<sup>5</sup>

There are no impediments to considering the petition in this matter. More than two years have elapsed since Dr. Hanson's probation began on September 25, 2019. As is evidenced by the letters of Dr. Daniel Gebhart and Dr. Erin Portillo attached within Exhibit D, Dr. Hanson's petition is accompanied by two verified recommendations from veterinarians who have personal knowledge of her activities since Dr. Hanson was placed on probation. Dr. Hanson also satisfactorily completed three years of informal criminal probation stemming from the conviction which triggered the disciplinary action and the Sutter County Superior Court's Order for Dismissal attached hereto as Exhibit H confirms that Dr. Hanson is not under sentence for any other criminal offense.<sup>6</sup>

In reviewing Dr. Hanson's petition, the Board may consider all her activities since the disciplinary action was taken, the offense for which she was disciplined, her activities since the license or registration was in good standing, and Dr. Hanson's rehabilitation efforts, general reputation for truth, and professional ability.<sup>7</sup> The amount of rehabilitation evidence required varies according to the seriousness of the misconduct.<sup>8</sup> Moreover, the evidentiary significance of misconduct is greatly diminished by the passage of time and the absence of similar, more recent conduct.<sup>9</sup> Passages from Dr. Hanson's narrative statement and letters from colleagues aware of her conviction, recovery group monitor and AA sponsor are excerpted later herein to demonstrate that her activities since the disciplinary action was taken reflect a character for truthfulness along with a dedication to living a sober lifestyle.

Much of the above case and statutory law is reflected by the provisions of California Code of Regulations, title 16, § 2041, wherein the Board has set forth the following rehabilitation criteria when evaluating a petition for reinstatement or petition for termination of probation:

- a. The nature and severity of the act(s) or crime(s) under consideration as grounds for denial.
- b. Evidence of any act(s) committed subsequent to the act(s) or crime(s) under consideration as grounds for denial which also could be considered as grounds for denial under Section 480 of the code.
- c. The time that has elapsed since commission of the act(s) or crime(s) referred to in subsections (a) or (b).
- d. The extent to which the applicant has complied with any terms of parole, probation, restitution, or any other sanctions lawfully imposed against the applicant.
- e. Evidence, if any, of rehabilitation submitted by the applicant.

Application of these rehabilitation criteria to the materials attached hereto will assure the Board that formal monitoring of Dr. Hanson is no longer necessary to ensure the public is adequately protected.

#### Application of Rehabilitation Criteria:

A. Nature and Severity of the Crime Under Consideration

Dr. Hanson is expected to acknowledge at hearing that her arrest and conviction for driving under the influence, and particularly the elevated range of her blood alcohol content at the time of her arrest, make her conduct more serious than the "average" driving under the influence offense. However, her actions were a symptom of the disease of addiction, not a reflection of some defect in Dr. Hanson's character. Therefore, despite the seriousness of her conduct, her treatment and cure of the underlying cause of that conduct mitigates the first criteria provided by § 2041(e).

In the following passage from her narrative statement, Dr. Hanson describes with painstaking detail the conduct which led to her November 21, 2017 arrest and the incredible shame and embarrassment she felt immediately following her arrest:

My arrest for driving under the influence occurred on 11/21/2017. The day and evening of the 20th, the day before my arrest, I was packing and getting the house ready for the cat-sitter for what I thought would be a Thanksgiving vacation. I was drinking all day and I remember staying up late that night and being intoxicated. Such was the nature of my addiction at that time that when I got up early for the morning flight and saw there was unfinished alcohol on my counter, I made a drink before driving to the Sacramento Airport where I was scheduled to fly out of to visit my brother for Thanksgiving. While driving through Yuba City, my vehicle hit the back of a CHP vehicle while rolling forward at a stoplight. I was breathalyzed, arrested and transported for booking. I was processed at the Sutter County Jail and spent the day in a holding cell. Never in my life had I been so ashamed, embarrassed and afraid of what my family would think. As I missed my flight, my brother and my sister very afraid and did not know what happened. I was released from custody at about 8pm at which time I finally texted my family. However, I was not emotionally able to talk to them for the next few weeks due to the shame I felt over my actions and what my life had become. I even recall thinking about how grateful I was that my parents were no longer alive to experience the disappointment and shame of their daughter's actions.<sup>10</sup>

Dr. Hanson thereafter continues her narrative statement by describing her early efforts in recovery, her initial denial of her alcoholism, and her relapse after a five-month period of abstinence following receipt of the Board's Accusation in Case No. 4602018000478:

At this time and for years prior, I had not been self-aware enough to admit to myself that my drinking was abnormal and that I was an alcoholic. I'd become increasingly isolated, living alone and avoiding friends as it would interfere with my drinking. Unfortunately, the DUI was not enough of a wake-up call. In the process of the legal/DMV consequences of the DUI, I did agree to go to a treatment at a 30-day alcohol/drug rehabilitation facility on the advice of my lawyer. I valued that experience, but upon returning home I returned to drinking. I knew that I had gained something through the treatment program as despite my drink [sic], I started going to local to AA meetings and was abstinent for the last 5 months of 2018. But by the time I received the big manilla envelope from the DOJ/VMB, I was back to drinking. I was completely blind-sided by the accusation and spun into fear and anxiety again. My probation started 9/25/2019, and I remember counting over and over again when I could have my last drink.<sup>11</sup>

The candid manner in which Dr. Hanson describes her early efforts in suggests she has fully embraced her 12-step program and developed meaningful insight into how she came to be in the position she finds herself in today. Through the strength of her recent recovery efforts, she has come to appreciate that she became an alcoholic long before her November 21, 2017 arrest. That she admits to the Board that the 30-day residential treatment program she completed between February and March 2018 was insufficient to prevent a relapse and that she was instead counting down the days of her last drink before beginning probation is another expression of the genuine candor we expect her to demonstrate when testifying at the hearing set on her petition.

B. No Further Acts of Misconduct

Although Dr. Hanson admits her DUI arrest and subsequent conviction did not entirely prevent her from drinking, that drinking did not result in any further arrest or conviction. Nor has the Board received any complaint which suggests there have been concerns of Dr. Hanson being impaired while serving as a veterinarian at VCA Valley Oak Veterinary Center where she has been employed for approximately fifteen (15) years. Instead, as the November 11, 2017 arrest prompting Dr. Hanson's February 21, 2018 conviction is the lone such act of misconduct in her nearly 35-year career, the 2<sup>nd</sup> rehabilitation criteria is squarely in favor of granting her the relief requested herein.

C. Passage of Time Since November 21, 2017 Arrest

By the time a hearing commences on Dr. Hanson's petition for termination of probation, five years will likely have elapsed since her arrest. The following passages from her statement suggest that Dr. Hanson has spent countless hours reflecting on how she became an alcoholic and recognizing the triggers which may have accelerated her down the path toward addiction:

> Veterinarians, and all medical professionals live in a culture of contradictions. We are highly trained and skilled doctors, but are also constantly reminded that medicine is not an exact science; there will be uncertainties and no guarantees of positive outcomes. On the other hand, quick and confident decision making is expected and poor outcomes are unacceptable. It is not a culture that is supportive of human weakness and fallibility. By the late 1990s, I was experiencing chronic anxiety, fear and depression as I tried to live with these expectations. Alcohol was a way to mute these feelings. This is a dysfunctional coping method that I have since learned unfortunately effects countless medical professionals. At the time, however, I lacked the awareness or tools necessary to address my feelings. What started as a daily habit of post-work drinking became a much more serious problem.

> In addition to these professional stresses, I experienced a great personal loss. In Dec 2007 my partner Ed was injured in a bicycling accident, sustaining a catastrophic injury. He suffered a mid-cervical spinal injury and became quadriplegic. He could breathe without assistance, but lost all use of his lower arms, hands and fingers. After returning from 3 months in the hospital, he required constant in-home care. We hired help during the day and initially I tried to cover the nights, but I was still working 3-4 days a week at that time and it was too much. Eventually we had to hire 24/7 professional in-home care. Ed lived for another 4 ½ years, dying in 2012. I had four years of pre-grieving the loss of a companion and a lifestyle of travelling, cycling and dining out. Losing him and the daily activities around the house left a huge hole that I filled with alcohol. I hate to reference Ed's tragic situation as a part of my addiction history; however, I do think it contributed to depression and accelerated my drinking to an alcoholic level.<sup>12</sup>

It is evident from the above passages from Dr. Hanson's statement that the time which has elapsed since her arrest, particularly the past two-and-one-half years in which she has truly embraced recovery, has allowed her to delve deeply inward and recognize now what she did not previously recognize about her relationship with alcohol. She recognizes alcohol as being a "dysfunctional coping method" and her lacking the appropriate "awareness or tools" to address her feelings about the professional pressures that accompany the practice of medicine. It is further apparent that she has been able to appropriately grieve, with a clean and sober mind, the loss of her significant other Ed, an incredibly traumatic event which unsurprisingly "accelerated [her] drinking to an alcoholic level."

Recognizing *why* she was abusing alcohol, not simply that she was abusing alcohol, is of course an important step in preventing recurrence of the conduct which prompted her placement on probation. Only with such recognition can one formulate a plan on how best to healthily cope with life's stressors and personal triggers. Dr. Hanson has been able to do just that by authoring the Relapse Prevention Plan that is attached hereto as Exhibit E.

#### D. Satisfactory Completion of Probation and Dismissal of Lone Conviction

As was referenced above, attached hereto as Exhibit H is an Order for Dismissal signed by the Sutter County Superior Court dismissing the criminal matter upon which the Board's disciplinary action was based. The Court's determination that it was appropriate to dismiss Dr. Hanson's conviction from her criminal record confirms that she satisfactorily completed probation for the entire period thereof and has not been charged with the commission of any other offense.<sup>13</sup>

E. Significant Rehabilitative Efforts

Dr. Hanson first credits the Board's probation for putting her on the "true path towards recovery" in her narrative statement. As she describes therein, although the Board did not mandate specific recovery modalities in placing her on probation, she resumed her participation in Alcoholics Anonymous meetings, obtained a recovery sponsor, put in place worksite monitors and with the help of a counselor, formulated a Relapse Prevention Plan that was approved by the Board.

In that Prevention Plan, Dr. Hanson writes that it is her "long-term goal and daily intention" to live life soberly and to continue her "personal journey of recovery and discovery." In specifically describing what her plan consists of, Dr. Hanson references her regular attendance in AA meetings, meeting with her sponsor, continuing the ongoing process of working the 12 steps of the program and making time daily for recovery reading and journaling. Very important for her, given her generally shy nature and prior inability to express her feelings regarding the pressure of practicing veterinary medicine, is that she attends an "All DVM" meeting once a week in which she is able to comfortably share with other veterinary doctors in recovery.

As she writes in her letter attached within Exhibit D, Maitrey Badami is a professor of Legal Studies at California State University Chico. Ms. Badami has maintained her sobriety for over twenty-five (25) years and has sponsored Dr. Hanson since March 2020. Of her experiences sponsoring Dr. Hanson, Ms. Badami writes in part as follows in her attached letter:

In the time I have worked with Suzanne, I have found her to be very honest and forthcoming in our conversations, despite her obvious shyness in meetings and reticence to speak in front of groups. She has been candid about her fears and concerns, places where she did not understand or relate to our AA literature, and her anxiety about reaching out to other alcoholics (an important part of cultivating a support network). **Despite all of her fears, she has steadfastly done the work of the 12 steps, acknowledging her alcoholism, seeking a connection with a "power greater than herself," forming a network with other recovering people** (in particular, she has gone to great lengths to connect with medical professionals in recovery, who share some of the same challenges she is dealing with), and **making**

amends to people she harmed in the course of her drinking. She has consistently pushed herself to follow my suggestions (for example, making outreach calls to other alcoholics in the program), even when they made her feel uncomfortable or awkward.<sup>14</sup>

The Board will find the above passage from a 25-year veteran in recovery to be an accurate depiction of Dr. Hanson at the hearing set on the attached petition. Dr. Hanson is, as she is also described by others who wrote on her behalf, a generally shy and private person. That shyness is something which Dr. Hanson acknowledges she previously treated by seeking solace in alcohol. However, by working the 12 Steps and with the help of others in recovery, particularly health-care professionals in recovery, she has overcome that shyness to candidly address her fears and concerns. This work by Dr. Hanson is an important indicator that her rehabilitative efforts are working.

Ms. Badami continues her letter by similarly describing her impressions that Dr. Hanson's recovery program is now something she is doing for herself and for the betterment of her quality of life, rather than to comply with the conditions of her probation:

In the course of our working together, I have observed her to become less guarded, less defensive, and more willing over time. She has notably shifted from doing recovery out of an obligation to the legal system or her profession, into pursuing recovery because it brings relief, freedom from anxiety, and peace of mind. While no one has the ability to predict with perfect accuracy who will "make it" and experience a life of permanent sobriety (I continue to characterize my own 25-year sobriety as one day at a time), from everything I have observed about Suzanne's work in our program, she is extremely likely to continue working the program, and to remain sober, after her probation has ended. Her motivation has shifted from an externally-driven desire to stay out of "trouble" into an internal drive to experience the benefits of sobriety.<sup>15</sup>

This became very clear when she received her cancer diagnosis and we had some real heart to hearts about what that meant. In the course of our conversations, she revealed that she has a strong desire to stay sober, no matter what, and that she understands that nothing life throws at her will be improved in any way by taking a drink. I am confident that she will remain sober, law-abiding, and continue to be a productive member of society upon the termination of her probation.<sup>16</sup>

It is important that Ms. Badami notes even after 25 years, she characterizes her recovery as "one day at a time." Yet, her opinion that Dr. Hanson is "extremely likely" to remain in recovery and remain sober should the relief requested herein be granted should not be taken lightly. Ms. Badami has

likely seen many "come and go" in recovery, so to speak, in the 25 years of her sobriety, and the manner in which she describes Dr. Hanson's attitude about sobriety should assure the Board that terminating formal supervision of Dr. Hanson's recovery will not present a danger to public safety.

Dr. Hanson also credits the support of her co-workers as an important aspect of rehabilitation and her Prevention Plan as they have served as worksite monitors and contributed to her becoming a "more attentive doctor and a happier person overall". Three of those co-workers wrote letters of support under the penalty of perjury endorsing Dr. Hanson's petition, attached within Exhibit D.

Erin Portillo is a Doctor of Veterinary Medicine and medical director of VCA Valley Oak Veterinary Center where she has worked with Dr. Hanson since 2007. In her attached letter, Dr. Portillo describes that she has worked closely with Dr. Hanson on numerous cases, attests to Dr. Hanson providing low cost fare for the local animal shelter in Chico, and describes Dr. Hanson's volunteer efforts at other animal shelters when not working at Valley Oak. It is evident from Dr. Portillo's letter that she would have suspected if Dr. Hanson had relapsed or were at all under the influence during the course of her employment. Dr. Portillo's letter also acknowledges awareness of the conduct which led to Dr. Hanson's placement on probation and describes how the latter made a "very public apology" to the doctors of VCA Valley Oak Veterinary Center:

As I mentioned Suzanne is a very private person. After her accident, she sought help and we supported her in her schedule because she is a good person and a valuable member of our team. During her recovery she made a very public apology to the entire doctor team at our monthly meeting. I can only imagine how difficult that must have been and I have so much respect for her. I admire the grace and dignity she has shown during her recovery and probation. She asks for help when needed and is communicates with us regularly.

It is without reservation that I fully support early termination of Suzanne Hanson's probation.<sup>17</sup>

Daniel Gebhart is also a Doctor of Veterinary Medicine and serves as co-medical director and part owner of VCA Valley Oak Veterinary Center. Like Dr. Portillo, Dr. Gebhart was moved by the manner in which Dr. Hanson took responsibility for the conduct underlying her placement on probation and apologized to her colleagues. In this respect, Dr. Gebhart writes as follows in his letter attached within Exhibit D:

After her DUI, Dr. Hanson has been a exemplary employee here at VCA Valley Oak. She apologized in front of her colleagues about being a alcoholic and what she was dealing with in her personal life. She discussed that she was

disappointed in herself but most importantly she felt like she let her colleagues down at our hospital. This statement was particularly moving for me, she showed incredible courage and bravery when she discussed her circumstance with us during that doctor meeting. Suzanne has been throughout a lot over the last 10 years and the courage and bravery she presents now is remarkable.<sup>18</sup>

In concluding his letter, Dr. Gebhart also provides his general impressions of Dr. Hanson's compliance with the conditions of her probation and dedication to her recovery:

I believe Suzanne has shown that she has gone above and beyond during the time she has been on probation. She checks in quarterly with Dr. Portillo and myself, she attends every doctor meeting and has shown humility and honesty with her probation and the events leading up to it. She has worked hard on her sobriety, attending AA meetings weekly and going through the steps. She has been sober now for several years and it has showed in her personality, work ethic and personal life. I am very proud of Suzanne and I know the rest of her friends, colleagues are as well.<sup>19</sup>

Jeanna Thompson serves as Hospital Manager at VCA Valley Oak Veterinary Center and has worked with Dr. Hanson for approximately three (3) years. Like her other colleagues, Ms. Thompson's letter describes Dr. Hanson as being a quiet but skilled practitioner. Ms. Thompson's letter further confirms that the VCA Valley Oak Veterinary Center has not received a complaint about Dr. Hanson and that the latter is instead "well liked" and "respected" by the facility's staff.

Ms. Thompson's letter similarly describes the manner in which Dr. Hanson notified her colleagues of her placement on probation and the conduct prompting that placement. Ms. Thompson writes that she was "amazed at the amount of humility and grace" in which Dr. Hanson addressed the situation. We expect that Dr. Hanson will present herself consistent with that description when testifying at hearing.

As she details in her Prevention Plan, another important aspect of Dr. Hanson's recovery is that she has changed her schedule over the last few years to better manage her stress and be more in control of her work. Dr. Hanson's initiative in changing her work schedule to alleviate some of the stress which contributed to her feelings of pressure and isolation during the active period of her addiction is another great indicator that she has been proactive in preventing the circumstances which contributed to her alcoholism.

Along with support of her siblings and self-care, both of which are undoubtedly key aspects of her recovery program, Dr. Hanson also credits her membership in the PAG monitoring program as an invaluable aspect of her rehabilitation. Attached hereto are letters from both Larry Collins, LMFT and Francine Farrell, LMFT describing Dr. Hanson's participation in PAG and endorsing her petition for early termination.

Along with being a licensed marriage and family therapist and previously holding certification as a certified alcohol and drug counselor, Larry Collins serves as the Group Facilitator for the Pacific Assistance Group ("PAG") in Chico, California. In his letter attached within Exhibit D, Mr. Collins describes his work in the field of recovery dating back thirty-six (36) years, including teaching positions at both the state and community college levels in the areas of psychology and addiction.

Aside from Dr. Hanson's own narrative statement, Mr. Collins' letter provides perhaps the best summary of the former's recovery journey with a candid description of Dr. Hanson's failures and successes. For example, Mr. Collins' letter acknowledges that Dr. Hanson relapsed after participating in an outpatient substance abuse recovery program and completing a residential treatment program. Mr. Collins' letter further references Dr. Hanson's initial cancer diagnosis, depression and sleep issues, and the loss of her partner Ed whose tragic death and impact thereof on Dr. Hanson is referenced in many of the attached materials.

Most importantly, however, Mr. Collins' letter, like Dr. Hanson's own narrative statement, describes her participation in PAG as the true catalyst for her embracing recovery as it was only through her participation in PAG that Dr. Hanson began truly caring for herself, consistently attending AA meetings, and realizing who she was without the presence of alcohol in her life. Through the counseling component of her PAG program, Dr. Hanson was able to appreciate her tendency to be shy and quiet around strangers, her inclination to isolate and how growing up in an alcoholic home may have contributed to her own alcoholism. Mr. Collins' letter suggests Dr. Hanson had not addressed the root causes of her addiction until she embraced the PAG program and all of its various components.

These sentiments are shared by Ms. Farrell, who describes her active involvement in supporting and monitoring Dr. Hanson's recovery since she enrolled in the PAG program effective November 20, 2019. Rather than writing on Dr. Hanson's behalf in a biased manner, Ms. Farrell describes Dr. Hanson as being initially uncertain of what benefit she may derive from participating in PAG aside from proving her compliance with the Board's probation. It appears from Ms. Farrell's letter that the turning point in Dr. Hanson's rehabilitation came when she was introduced to other professionals in recovery and began working the 12-Step program. In this respect, Ms. Farrell writes as follows regarding the change she observed in Dr. Hanson:

Previous resistance turned into a deepening gratitude and acceptance of a new, sober values system and way of life. The benefits of sobriety and of the recovery program

she has built can only be described as transformational. I believe Dr. Hanson would now describe herself as "a grateful alcoholic."<sup>20</sup>

After describing the components of Dr. Hanson's PAG agreement, Ms. Farrell writes as follows regarding the former's compliance with that agreement:

Dr. Hanson has participated in the program fully and has demonstrated meticulous compliance with her PAG program requirements. She has also demonstrated lasting and meaningful changes in attitude and behavior consistent with ongoing abstinence and working a program of recovery.<sup>21</sup>

Ms. Farrell further describes Dr. Hanson as a "very valued member" of her support group and writes that the latter's "introversion has yielded to more openness and a deep connection with peers in recovery." Elaborating on the meaningful changes she has observed in Dr. Hanson since her initial apprehension as to the benefits of PAG 2 <sup>1</sup>/<sub>2</sub> years ago, Ms. Farrell writes in part:

Dr. Hanson has embraced sobriety. She values her recovery. She is grateful for the new life that sobriety has brought her. We have seen a dramatic changes in her functioning, thinking and behaviors. She demonstrates strong recovery and offers much to newcomers, sharing her "experience, strength and hope." Her willingness to be open, honest and transparent with herself and others serves as an example to her peers in the program. She is clearly respected and appreciated by fellow group members.<sup>22</sup>

After describing Dr. Hanson's prognosis for continued sobriety as being "excellent", Ms. Farrell concludes her letter attached as Exhibit C in the following manner:

In summary, I would state that **Dr. Hanson has undertaken and achieved a** meaningful and lasting change in her life as a result of the very painful event that originally brought her into recovery. Her steadfast compliance and acceptance have been well documented, and she has successfully maintained her commitment to sobriety even during difficult challenging periods. As you know, her current health situation could have been a trigger for someone with a weaker commitment to recovery. Instead, she deepened her resolve in living a strong recovery program.

I believe she is successfully rehabilitated and has the relapse prevention tools she needs to maintain her program. I hope the Veterinary Medical Board and the

Attorney General's office will see this as worthy of acknowledgment and will move for early termination of probation.<sup>23</sup>

Although it ultimately was insufficient to prevent a relapse, further evidence of Dr. Hanson's rehabilitative efforts since the conduct underlying her disciplinary action was her 30-day residential treatment at Duff's Napa Valley Rehab. Attached hereto as Exhibit F is a letter confirming that treatment.

### Other Relevant Considerations:

Dr. Hanson's veterinary skill was not called into question in Case No. 4602018000478. However, the following passage from Dr. Gebhart's letter should assure the Board that the former is a veterinarian and person of the highest quality:

I am very proud of Dr. Hanson over the last few years. She is a great employee who works very hard, she is also very compassionate and is a skilled and knowledgeable general surgeon. Suzanne's mood and attitude have been excellent for the last couple years. She is a great team player and is always willing to help others. She is always continuing to learn more and further her veterinary skills. I greatly appreciate her company and consider a great friend and colleague. Suzanne is always punctual and comes into work with a great attitude.

Suzanne is very professional with clients, staff and her fellow colleagues. She is easy to talk to and very helpful along with having a great and witty sense of humor. She is very helpful with our community, volunteering her time at our local shelter (Butte Humane Society and Chico Animal Shelter) spaying and neutering patients for the City of Chico. She donates her time and helps out at the shelter weekly spaying and neutering patients. Suzanne is well received in the veterinary community in Chico California and has been for many years. She dedicated herself to helping out many burned patients during the CAMP fire in 2018 and Bear Fire in 2020 not only here at VCA Valley Oak but also at the shelter.<sup>24</sup>

The manner in which Dr. Hanson is described in the above-excerpted passage—exhibiting an excellent mood and attitude, always willing to help others, continuously improving upon her veterinary skills, always punctual and freely volunteering her time to help others less fortunate than her—is in stark contrast to how Dr. Hanson describes who she was during the active period of her addiction in her narrative statement. That she is now reaping the benefits of sustained sobriety and intends to continue her participation in PAG irrespective of the Board's determination of her petition – a program with more than an 85% success rate – should assure the Board that formal supervision of Dr. Hanson's recovery is no longer necessary to ensure the public remains safe.

Further evidence of Dr. Hanson's commitment to providing only the highest caliber veterinary care can be found attached hereto as Exhibit G, where the Board will find certifications confirming eight-five (85) hours of continuing education since September 1, 2019.

### Conclusion:

Dr. Hanson fully acknowledges her addiction. Through her efforts in PAG, she has recognized the sources of her addiction and the triggers that accelerated her alcoholism, and has developed a strong and comprehensive support network to prevent relapse. Dr. Hanson has not produced any positive test results while on probation and has meticulously complied with the terms of her probation agreement. She now comes before the Board to petition for termination of probation so that she may spend more time with her loved ones, appropriately confront the recent return of her cancer diagnosis, and hopefully travel internationally as she winds down her professional practice.

Rehabilitation is a state of mind, and the law looks with favor upon rewarding the opportunity to serve, one who has achieved reformation and regeneration.<sup>25</sup> As the materials attached hereto demonstrate that Dr. Hanson has achieved reformation and regeneration, we ask the Board to look reward her rehabilitative efforts by terminating the balance of her probation. On Dr. Hanson's behalf, thank you all for your thoughtful consideration.

Mr Petersen, My lawyer and I are wrapping up my Early Release package to be sent to the Board. One question is the remaining balance on my Cost Recovery, so I looked on Cal Breeze. It shows \$769.50 remaining on a Cost Recovery of \$1,717.50 and \$3,861.00 on my 5000.00 fine outstanding. The amount of the Fine is stated in my Decision, and the Cost Recovery figure is from a letter I received at my intake interview with the Board, from Sidney Villareal, dated 9/11/19. I've attached a copy of that letter.

Since 11/2019, I've been paying the Board 274.00\$ each month, a combination of pro-rated CR abd Fine amounts that was worked out by Ms Villareal. So at \$274.00 X 30 months, that's \$8220.00. It seems that amount should more than cover those fees/fines, with of course an ongoing monthly cost.

Cal Breeze doesn't show a running total of my payments, so none of this makes sense to me. I tried calling the Board this am but was not able to reach a live person. Hopefully you can help me understand this difference in math.

Dear Members of the Veterinary Medical Board,

I am writing this narrative to accompany my application for Early Termination of Probation. I was placed on Probation by the Board on Sept. 25, 2019 after my November 2017 arrest and February 2018 conviction for driving under the influence. The purpose of this narrative is to briefly describe who I am today, with two and one half years of sobriety, the events surrounding my arrest, my addiction history, my recovery efforts and why I am requesting that the balance of my probationary period be terminated.

Originally, I am from Southern California and moved to Northern California in 1983 to attend veterinary school. I graduated from UC Davis School of Veterinary Medicine in 1987. From 1987 to 1991 I worked at Loomis Basin Veterinary Clinic in Placer County. I moved to Chico in 1991 where I worked as an associate veterinarian until 1996. At that time, I bought a small solo practice in Chico. In 2007 that practice was bought by another local office, that eventually evolved into a multi doctor specialty and emergency practice where I work now. This practice, Valley Oak Veterinary Center, was originally privately owned until it was purchased by VCA/Mars several years ago. Upon first moving to Chico, I became involved in the local veterinary association, and also held a 6-year term on CVMA's Board of Governors. I started working with Chico Animal Services back when I had my own practice. I continue to do both pro bono and paid work for them, and also work for our local SPCA one day a week.

My arrest for driving under the influence occurred on 11/21/2017. The day and evening of the 20<sup>th</sup>, the day before my arrest, I was packing and getting the house ready for the cat-sitter for what I thought would be a Thanksgiving vacation. I was drinking all day and I remember staying up late that night and being intoxicated. Such was the nature of my addiction at that time that when I got up early for the morning flight and saw there was unfinished alcohol on my counter, I made a drink before driving to the Sacramento Airport where I was scheduled to fly out of to visit my brother for Thanksgiving. While driving through Yuba City, my vehicle hit the back of a CHP vehicle while rolling forward at a stoplight. I was breathalyzed, arrested and transported for booking. I was processed at the Sutter County Jail and spent the day in a holding cell. Never in my life had I been so ashamed, embarrassed and afraid of what my family would think. As I missed my flight, my brother and my sister very afraid and did not know what happened. I was not emotionally able to talk to them for the next few weeks due to the shame I felt over my actions and what my life had become. I even recall thinking about how grateful I was that my parents were no longer alive to experience the disappointment and shame of their daughter's actions.

After being released from the jail that night, I got a room and stayed overnight in Yuba City. On Nov 22, I arranged to have my car towed back to Chico. As I was "on vacation" I had all week to stew in my self-pity and despair. Within several days I received a letter from the VMB that they had been notified of the DUI. Amazingly, I never put 2 + 2 together and had no thought that there might be professional consequences as a result of my arrest. I returned to work the next week. Some of my co-workers knew that something had happened on the 21st, but not the details. I did tell my Dr-managers within a few weeks that I'd received a DUI.

At this time and for years prior, I had not been self-aware enough to admit to myself that my drinking was abnormal and that I was an alcoholic. I'd become increasingly isolated, living alone and avoiding friends as it would interfere with my drinking. Unfortunately, the DUI was not enough of a wake-up call. In the process of the legal/DMV consequences of the DUI, I did agree to go to a treatment at a 30-day alcohol/drug rehabilitation facility on the advice of my lawyer. I valued that experience, but upon returning home I returned to drinking. I knew that I had gained something through the treatment program as despite my drink, I started going to local to AA meetings and was abstinent for the last 5

months of 2018. But by the time I received the big manilla envelope from the DOJ/VMB, I was back to drinking. I was completely blind-sided by the accusation and spun into fear and anxiety again. My probation started 9/25/2019, and I remember counting over and over again when I could have my last drink.

Veterinarians, and all medical professionals live in a culture of contradictions. We are highly trained and skilled doctors, but are also constantly reminded that medicine is not an exact science; there will be uncertainties and no guarantees of positive outcomes. On the other hand, quick and confident decision making is expected and poor outcomes are unacceptable. It is not a culture that is supportive of human weakness and fallibility. By the late 1990s, I was experiencing chronic anxiety, fear and depression as I tried to live with these expectations. Alcohol was a way to mute these feelings. This is a dysfunctional coping method that I have since learned unfortunately effects countless medical professionals. At the time, however, I lacked the awareness or tools necessary to address my feelings. What started as a daily habit of post-work drinking became a much more serious problem.

In addition to these professional stresses, I experienced a great personal loss. In Dec 2007 my partner Ed was injured in a bicycling accident, sustaining a catastrophic injury. He suffered a mid-cervical spinal injury and became quadriplegic. He could breathe without assistance, but lost all use of his lower arms, hands and fingers. After returning from 3 months in the hospital, he required constant in-home care. We hired help during the day and initially I tried to cover the nights, but I was still working 3-4 days a week at that time and it was too much. Eventually we had to hire 24/7 professional in-home care. Ed lived for another 4 ½ years, dying in 2012. I had four years of pre-grieving the loss of a companion and a lifestyle of travelling, cycling and dining out. Losing him and the daily activities around the house left a huge hole that I filled with alcohol. I hate to reference Ed's tragic situation as a part of my addiction history; however, I do think it contributed to depression and accelerated my drinking to an alcoholic level.

My true path towards recovery began when I started probation in September 2019. Between the time I received the accusation from the DOJ in April 2019 and starting probation, I tried to control my drinking on my own. I did not return to AA or ask anyone for help during this time. Efforts at controlled drinking (not drinking on work-nights, limiting the number of drinks) were a failure. Recognizing that I could not control my drinking and the tolerance to alcohol I had developed, I had unknowingly taken the first of the 12 Steps by acknowledging I was powerless over alcohol. The Board did not prescribe specific recovery activities, so with the help of a counselor, I wrote my own "Treatment Plan" that was accepted by the Board. It was a combination of personal and group counselling, attending AA meetings/getting a sponsor and informal monitoring by my work colleagues. At a later date, I decided put in place formal workplace monitors to give myself an additional layer of accountability.

Another large part of my ongoing recovery plan is working with Pacific Assistance Group (PAG). If you are unfamiliar with this group, I have enclosed a flyer and my most recent contract with them. I joined PAG voluntarily, agreeing to their more rigid requirements, again as an additional layer of accountability. Many of PAG's facilitators came from jobs at the California Medical Board, before the CMB ended its in-house Diversion program. Slowly, by working with my AA sponsor and the PAG counselors, I gained the acceptance and willingness to commit myself to lifelong recovery and sobriety.

Since joining PAG in fall of 2019, I've attended one 90-minute group counseling session per week; initially in-person, now on Zoom. I was soon invited to join an additional PAG group on Saturdays, also

on Zoom. I am the only veterinarian in both of these groups. Most other members are MDs or DDSs. These meetings are excellent. We talk about all areas of addiction, recovery, share probation experiences and give advice to one another. The meetings are not strict AA/NA format, so gentle "crosstalk" is allowed, and they are facilitated and supported by very experienced addiction counselors.

I do attend regular AA meetings and have worked and am continuing to work the Steps with my sponsor. This included making in-person amends (Step 9) to my colleagues for times I let them down. I currently attend a combination of in-person and on-line AA meetings, including an all DVM group through VIN. I document and report these meetings to PAG.

Daily, I read recovery materials and write in my journal. This is a quiet time first thing in the morning that I enjoy. To be my best in recovery, at work and in life in general, I take care to eat properly, get good sleep and get outdoors. Per the Board's requirement, I notified all licensed staff at my workplace that my license is on probation. To my pleasant surprise, my colleagues have become informal monitors of my behavior and demeanor at work. I also have our office manager and one of my Dr-managers submitting formal quarterly reports on me to PAG.

I have been respectful of the Boards monitoring requirements, never missing or having a questionable test, including when I've travelled within the US. I am current with all fees. As a result of these efforts and with the help of a power greater than myself, I have lost the desire to drink. I am living peacefully with much less anxiety and fear. These recovery activities have become a guide for daily living; they keep me sober both physically and emotionally. Throughout my career I have enjoyed attending Continuing Education (CE) events. In person CE came to a screeching halt due to covid so the CE certificates accompanying my petition are a combination of in person and online events.

By the time this Petition is decided upon, I will have completed close to three out of the five years of my probationary term. I will also be near 65 years of age and approaching semi- and then full retirement. There are several reasons I am petitioning the board for Early Release. Firstly, I have a strong ongoing recovery program, centered on AA, PAG and the personal introspection I have done over the last two plus years. In fact, it is my intention to remain with PAG post-probation as PAG has an 85% success record with graduates that participate for 5 years. On a more practical level, I would like the freedom to travel internationally. VMB monitoring does not allow for this. PAG has additional methods of monitoring that allow for more relaxed and free travel options. Once of retirement age, I would like to work less than the Board's hours worked per week requirement. And when I do fully retire, I would like to do so with my license intact.

Additionally, I've had a recent change in health status that will affect my future. In late 2021, I was diagnosed with metastatic breast cancer. My prognosis is favorable for the next 2-5 years, but I will be facing multiple Dr appointments, diagnostics and treatments. I do not know yet how this will affect my job and career. With this in mind, I will be prioritizing my life differently, maximizing time with family and friends. I cannot predict how many days I might be occupied with medical treatments, in hospital or feeling ill. Trying to meet the Board's testing requirements could be challenging. Again, I would like to spend this time with my veterinary license intact. I will surely continue my recovery activities and utilize my relapse prevention tools with our without the Board's formal supervision.

Thank you all for taking the time to review this Petition. I appreciate your consideration.

I am a Licensed Marriage and Family Therapist and a Certified Alcohol and Drug Counselor, as well as the Area Administrator for **Pacific Assistance Group North** monitoring and support program. As such, I have been involved in assisting veterinarians and other health care professionals who have become potentially impaired due to substance use disorders and other mental health diagnoses for more than 30 years.

Suzanne Hanson, DVM, referenced above, enrolled in the **Pacific Assistance Group** Program for monitoring and support effective November 20, 2019. At that time, she was ordered by the Veterinary Medical Board to "enroll in a rehabilitation program for alcohol or drug." She chose Pacific Assistance Group as her program and was, at first, somewhat uncertain what benefit it might have beyond compliance with the probation order. I have been actively involved in supporting and monitoring her participation throughout this time.

Dr. Hanson began to attend the Health Professionals Support Group in Chico, CA and was soon introduced to other professionals in recovery and to the 12-Step programs. Previous resistance turned into a deepening gratitude and acceptance of a new, sober values system and way of life. The benefits of sobriety and of the recovery program she

has built can only be described as transformational. I believe Dr. Hanson would now describe herself as "a grateful alcoholic."

Dr. Hanson's current signed agreement requires:

- 1. Agreement for the period November 20, 2019, through September 25, 2024 (or as needed to coincide with terms of probation)
- Random Urine Testing daily call-in, randomized, observed tests

   Conducted by the Veterinary Medical Board
- 3. Regular attendance at the Health Professional Support Group (she is routinely attending group in Chico and in Sacramento virtually)
- 4. Regular participation in recovery activities, including healthy lifestyle and family activities

Dr. Hanson has participated in the program fully and has demonstrated meticulous compliance with her PAG program requirements. She has also demonstrated lasting and meaningful changes in attitude and behavior consistent with ongoing abstinence and working a program of recovery.

COVID-19 caused the weekly support group to become a virtual group in March of 2020. Dr. Hanson has voluntarily attended more frequent health professional support groups, including virtual support groups facilitated by her case manager, Ann Leber. I have also had direct interaction with Dr. Hanson and with her case manager regularly in the administrative role I have played in overseeing her program of recovery. Ms. Leber reports she has routinely seen Dr. Hanson interact with peers in group in a very positive and recovery-oriented manner. Suzanne is a very valued member of the support group. Her introversion has yielded to more openness and a deep connection with peers in recovery.

Dr. Hanson has embraced sobriety. She values her recovery. She is grateful for the new life that sobriety has brought her. We have seen a dramatic changes in her functioning, thinking and behaviors. She demonstrates strong recovery and offers much to newcomers, sharing her "experience, strength and hope." Her willingness to be open, honest and transparent with herself and others serves as an example to her peers in the program. She is clearly respected and appreciated by fellow group members.

As you know, she has participated in random testing regularly through the Veterinary Medical Board's program and has demonstrated no lapse in sobriety during her probation period. Based on her self-reports, knowledge of 12-Step, lifestyle activities and impromptu discussions with us at Pacific Assistance Group, it would appear to me that she does, in fact, celebrate two- and one-half years of continuous sobriety at this time.

Prior to that I had worked in human medicine management for about ten years. In my current position I work with our two medical directors to manage this hospital which includes the doctors and support staff. Suzanne is one of the veterinarians working at my practice, Valley Oak.

In my first few weeks at this hospital, I spent time observing the doctors and staff. My first impression of Suzanne was that she was a knowledgeable but seemingly quiet doctor who was clearly skilled in her profession. I would assume that she is respected by them as they read and respond to her emails when they are sent, rather than ignoring them.

As a surgery doctor in our practice, she often does very tedious and strenuous work and still does not raise her voice or get frustrated with staff. She is well liked and respected and they are happy to help her in any situation. In addition, in my position, I am the person that handles client complaints, particularly if they pertain to my doctors. To date, I have not had a complaint about Suzanne's bedside manner or in her skills as a doctor.

Perhaps my favorite memory to date about Suzanne was in November 2020. Covid was on a rampage and we as a hospital were incredibly busy. We have a rotation for holidays so that no one has to work every holiday. However, Suzanne has always offered to work Christmas so that others can spend the time with their families. But, in November 2020, Suzanne was scheduled to be on vacation the week of Thanksgiving. Instead of going to see family, she came to the hospital and made Thanksgiving dinner for all of the staff working. This is was no small undertaking as there were about 20 people working. She didn't have to do that, but she wanted them to have a home cooked meal because it had been a hard year for everyone.

I am submitting this declaration on behalf of Suzanne Hanson's request for the early termination of her probation.

I am an attorney, a professor of Legal Studies at California State University, Chico, and a recovering alcoholic. I have been continuously sober since January 23, 1997.

I met Suzanne at an Alcoholics Anonymous meeting in Chico. I don't recall the date, but it was prior to the COVID-19 pandemic that shut down our in-person meetings for a period of time. I believe it was at the beginning of 2020. She indicated she was seeking a sponsor, a person with whom she could work through the 12 steps of AA. I agreed to take on that role for her, a process I have done with numerous women in the time I have been a member of AA.

We have worked together continuously for the past two years. I have a record of receiving emailed step work from her as early as March, 2020, and I know that we had a few meetings together in person prior to shifting to primarily "virtual" and telephone meetings during the early portion of the pandemic shutdown. We also met to take socially distanced walks on several occasions, in order to allow her the benefit of in-person checking in, during a time that was challenging for all newly sober people. She remained in regular contact with me by phone in between our meetings.

In the time I have worked with Suzanne, I have found her to be very honest and forthcoming in our conversations, despite her obvious shyness in meetings and reticence to speak in front of groups. She has been candid about her fears and concerns, places where she did not understand or relate to our AA literature, and her anxiety about reaching out to other alcoholics (an important part of cultivating a support network). Despite all of her fears, she has steadfastly done the work of the 12 steps, acknowledging her alcoholism, seeking a connection with a "power greater than herself," forming a network with other recovering people (in particular, she has gone to great lengths to connect with medical professionals in recovery, who share some of the same challenges she is dealing with), and making amends to people she harmed in the course of her drinking. She has consistently pushed herself to follow my suggestions (for example, making outreach calls to other alcoholics in the program), even when they made her feel uncomfortable or awkward.

In the course of our working together, I have observed her to become less guarded, less defensive, and more willing over time. She has notably shifted from doing recovery out of an obligation to the legal system or her profession, into pursuing recovery because it brings relief, freedom from anxiety, and peace of mind. While no one has the ability to predict with perfect accuracy who will "make it" and experience a life of permanent sobriety (I continue to characterize my own 25-year sobriety as one day at a time), from everything I have observed

about Suzanne's work in our program, she is extremely likely to continue working the program, and to remain sober, after her probation has ended. Her motivation has shifted from an externally-driven desire to stay out of "trouble" into an internal drive to experience the benefits of sobriety.

This became very clear when she received her cancer diagnosis and we had some real heart to hearts about what that meant. In the course of our conversations, she revealed that she has a strong desire to stay sober, no matter what, and that she understands that nothing life throws at her will be improved in any way by taking a drink. I am confident that she will remain sober, law-abiding, and continue to be a productive member of society upon the termination of her probation.

I met Suzanne Hanson shortly after I arrived in Chico in 1990. She then worked at a local veterinary practice and I saw her whenever my pet needed attention. Her intelligence, competence, and good sense were manifest in her professional demeanor and "catside" manner. She provided compassionate and sensible care to my animals and welcomed both my opinions and queries. I've encountered many veterinarians as I've moved around the US (Maryland, Virginia, Minnesota, Ohio, Nebraska, and California) for work. Given those experiences, I can say with confidence that Dr. Hanson is among the best I've ever known.

Much to my surprise and delight, I came across Dr. Hanson in a non-professional setting in 1993 when I began to attend the church she belonged to in Chico CA. We developed an ongoing relationship that came to include our respective families and work colleagues. Suzanne has proven herself over the years to be a kind and caring friend who can be relied upon for help and support. Her generosity extends beyond her circle of friends and out into the wider community. Her ongoing engagement in the care and treatment of Butte County's animal population through the SPCA and Chico Animal Shelter exemplifies her desire to be of service.

Since 2007, Dr. Hanson has faced a series of significant personal challenges. Her life partner suffered a catastrophic injury that year which destroyed what had been a life full of travel and shared interests. Ed's near total debilitation meant that Suzanne had to assume complete responsibility for their household, his care, and still go to work. While their friends and family did what we could to lighten the load, it still fell to Suzanne to manage his complicated care regimens and schedules. Until Ed's death in 2012, she was constantly dealing with physical, emotional, and spiritual exhaustion. And yet she persevered, serving her clients and colleagues while dealing with this horrendous personal tragedy.

More recently, Dr. Hanson has experienced even more hardships. She was diagnosed with breast cancer in late 2017 and had surgery and radiation treatments (both successful) in early 2018. Nearly simultaneously, Suzanne was also dealing with the personal and professional fall-out arising from her DUI in late 2017. While her road to sobriety has had some setbacks, she has been sober since late 2019. Suzanne's shared information with me about her ongoing recovery efforts that include AA, a substance monitoring program, and personal counseling. She is scrupulous about working her program, seeking support from her sponsor, and doing what she can to bring balance and joy into her daily life. As her friend, I am so very proud of the tenacity, humility, and courage she continues to demonstrate while continuing the hard work necessary to sustain her sobriety.

As the Group Facilitator for the local Chico Pacific Assistance Group Program since 1997 (in prior years I was also the Group Facilitator for the California State Medical Board Diversion Program), I am writing in support of Suzanne Hanson's request for Early Release from her Probation with the Veterinary Medical Board of California.

I have worked in the recovery field for 36 years, taught at both the State and Community college level in the areas of psychology and addiction. I was employed for a time by the California State Medical Board Diversion Program as a Case Manager, and have served in various capacities for Pacific Assistance Group.

According to my records I first met Suzanne for an Intake on 10-16-19 into my private practice following a referral from a local doctor, Brandan Stark, D.O., whose outpatient Substance Abuse Recovery Program she had been attending, after completing a residential treatment episode at Duffy's in California. She had been cited with a DUI 2 years prior after which she continued with AA meetings, but without sponsorship. She stated to me she had continued her new sobriety from June to December that same year but resumed "moderate" use of alcohol, first cooking with wine, then resuming drinking several days weekly. She had also stated at the Intake her last use of alcohol had been on approximately 09-20-19. Suzanne's history of alcohol use went as far back as the 19080s, but seems to be without incident

There were many events Suzanne experienced around this time, including a cancer diagnosis and surgery, the closing of her private veterinary practice and taking position at Valley Oak Veterinary Center in Chico, California. She also had experienced some depression and sleep issues for which she had been being treated. Of note, some years later in 2007 her significant other was severely injured in an auto accident and later deceased in 2012.

By the Fall of 2019 the Board had determined the Decision and Order for her case and by January of 2020 she had connected with Pacific Assistance Group in order to outline a program of monitoring which included weekly, in-person group in Chico for support and monitoring. Her program included in addition both weekly group meeting, random UA testing, and some individual therapy as needed.

Suzanne continued to see her primary care physician for depression and sleep issues, and began to employ some self-care components of daily walks, attended AA meetings, and explored what a "non-drunk Suzanne" was like. Suzanne came to recognize her tendency to isolate, presented as quite shy and quiet, and was anxious about sharing her story in the AA meetings. In her individual therapy she addressed these issues along with her family of origin experience of growing up in an alcoholic home. She began to seek out a support/therapy group for this.

Over her time in the PAG program, along with her AA meetings, her recovery included additional support groups through PAG; reading recovery materials; she began to explore her isolation tendencies, and began to find she had some motivation for changes. Some of these changes have including taking the risk of sharing in the PAG groups, opening up and revealing her thoughts and feelings and needs. Suzanne began to create a plan of self-care, establish new goals regarding self-image and self-confidence, and develop and maintain healthy personal boundaries. An early issue for many folks in recovery is regarding how to enjoy oneself, have fun, and relax. Suzanne loves to read, watch golf tournaments on TV, and enjoy relaxing evenings with her cat family.

It has been a pleasure to see Suzanne establish herself in her new clean and sober lifestyle. She seems to enjoy her work at the veterinarian clinic and evidently gets along well with other staff and is able to support others as they work toward common goals for their animal patients. It is my understanding that she has made efforts to connect more closely with her siblings over the past couple of years, and although still somewhat quiet and reserved, there has been a significant blossoming as we have seen the recovery lifestyle provide her with its rewards and benefits.

For most professionals in recovery, the experience of a monitoring program is often frightening and intimidating, overwhelming and seemingly impossible to maintain compliance. Initially it can be very confusing. Overall it can be very expensive. Attempting to keep a normal work schedule, attend the required monitoring and recovery meetings, and have somewhat of a normal social and/or family life, can be extremely challenging. There were times when Suzanne felt she may not be able to do it. Her perseverance and dedication to this new lifestyle eventually became reinforcing in itself. She found her way, kept steady and maintained the course. She remains on this journey.

#### Suzanne Hanson

Included in my Petition for Early Release from Probation and personally relevant to anyone in recovery, including myself; is a Relapse Prevention Plan. It is my long-term goal and daily intention to remain sober, striving to provide my clients and patients with the best, most thoughtful care possible, and to continue my personal journey of recovery and discovery. Items in my plan are persons, places and things that support me personally and especially my recovery.

- To continue as a member of Pacific Assistance Group (PAG) during my remaining working years. PAG has an 85% long term recovery rate when clients complete a 5-year program. This contract will include weekly group meetings and random drug/alcohol testing, but with the flexibility to travel.
- 2. Regular AA meetings, talking and meeting with my sponsor, continuing to work on the 12 steps, taking time daily for reading and journaling related to my recovery program. This work has helped me find strength not ordinarily my own, and to find peace of mind in the face of difficult circumstances. There is an "All DVM" AA meeting once a week through VIN. This group is very helpful; it is a safe, comfortable and anonymous group where we can share work related issues that would not be appropriate for a "regular" AA meeting.
- 3. The support of my co-workers. They provide many sets of eyes to monitor my work activities. As the letters from my Dr/managers attest, since settling into Probation and recovery, I have been a more attentive doctor and a happier person overall.
- 4. Ongoing Continuing Education meetings. I enjoy these events and they help to keep me current with our rapidly changing profession.
- 5. Managing Stress. Over the last 2 years I have asked to have my work schedule changed. I now mainly do surgery and procedures and have less client contact. I'm a bit more in control of my daily workflow.
- 6. The support of my family. My brother and sister are aware of the DUI, that I no longer drink and that I regularly attend PAG and AA groups. They have been very compassionate and supportive over the last 4 years.
- 7. Taking care of myself. This means getting enough sleep, eating well, getting outdoors, reading recovery material and for pleasure, maintaining a healthy work-life balance. To me it also means paying attention to the people, places and things that are not healthy for us, things that could trigger a relapse. When negative situations are encountered, I'm learning to recognize and accept them for what they are, letting them pass and not using them as a reason to look for solace in a glass.

Hopefully, these elements will serve me well as I move forward in my career and my life.
