#### **Examination Updates**

International Council for Veterinary Assessment (ICVA)

On <u>July 5, 2023</u>, ICVA provided an updated on the ICVA Assessment Grant Program. The ICVA Academic Veterinary Assessment Committee, for the fifth year, announced its successful assessment grant program with up to three grant award opportunities of \$10,000 USD. The deadline was June 30<sup>th</sup>, with a total of seven letters of intent received. The letters are being reviewed by the ACAC and invitations for full submissions will be made by early august. The full proposal submission deadline is October 30, 2023.

#### **Examination Statistics**

Below are the final examination results for first time test takers for last fiscal year (July 1, 2022 – July 30, 2023). The North American Veterinary Licensing Examination (NAVLE) and Veterinary Technician National Exam (VTNE) reflect the national pass rates. The Veterinary Law Examination (VLE) is only for California applicants.

#### **Licensing Updates**

### Continuing Education (CE) Audits

Over the last quarter, the Board conducted 66 Veterinarian and 48 Registered Veterinary Technician (RVT) CE audits. Of those, roughly 19% of Veterinarians and 10% RVTs were non-compliant. Corrective measures may include educational letters, citations, or disciplinary actions depending on the severity of the non-compliance.

#### **Board Applications**

Overall, Board applications saw a decrease of roughly 7% (1,233 to 1,141) when compared to Quarter 1 (Q1) FY (Fiscal Year) 22/23. Veterinarian applications decreased approximately 24% (190 to 144), University decreased by 70% (40 to 12), RVT

increased by 17% (305 to 357), Premises (HSP) decreased by 28% (132 to 95), and Veterinary Assistant Controlled Substance Permits (VACSP) noticed a small decrease of 6% (566 to 533).

## Licenses, Registrations, Permits Issued

Overall, Board licenses saw a decrease of roughly 16% (1,164 to 982) when compared to Q1 FY 22/23. Veterinarian licenses decreased roughly 17% (250 to 208). University licenses slightly decreased (10 to 9), RVT licenses increased 9% (230 to 250), HSPs decreased 38% (128 to 79), and VACSPs decreased 20% (546 to 436).
